Short-term rentals are further regulated by Article DD of the Zoning Ordinance. The +/- 14,600 sq. ft. property is addressed as 43 Maplehurst Drive and is identified as tax map parcel 18-M-7.

Alley Closing - Adjacent to 211 East Washington Street
