In regards to the rezoning request for a Major Family Day Home located at 1214 Windsor Drive, the Fire Department has no objections to granting the request.

I have had our response records researched from January 1, 2008 to date, and as the attached report indicates, I can see no indication that day care operations generate more emergencies than other occupancies. As you can see by the report, the populations at these day care operations range from 12 to 169 children. The highest number of responses was for the Boy's & Girls Club, located in the Simms Building, and The Harrisonburg Rockingham Day Care Center, located in the Muhlenberg Church on East Market Street. In both cases, most of the responses were related to false or unintentional fire alarms, and were associated with the entire building, rather than just the day care operation.

Also, you can see at the bottom of this report that since January 1, 2008 we have responded to addresses on Nelson Drive a total of 20 times. While it is steep, we have never had any issues negotiating the hill on Nelson Drive.

As far as Windsor Drive, we have responded to Windsor Drive a total of ten times since June 11, 2010. Of those ten responses, five were for the 1214 Windsor Drive address, with four of the responses being for EMS calls, and one response, by just a Deputy Fire Marshal, for an unauthorized burn.

Windsor Drive has approximately 19 feet of pavement in front of the 1214 Windsor Drive address. This is just one foot less than what the State Fire Code requires for Fire Lanes on private property. The road does narrow to about 15 feet of pavement at the end of the road. As with Nelson Drive, our personnel have not reported any issues traveling Windsor Drive. However, this does not mean that the road should not be improved.

The Department of Social Services requires a license to operate a day care facility that accommodates 12 children. Annual inspections, including fire inspections, are a requirement of that licensing process. The Fire Department is notified by Social Services when these inspections are due. The attached list of day care operations was generated by our inspection files as a result of past Social Services notifications. According to Don Driver, Social Services Director, Ms. Dorsey has applied to Social Services for a license

to expand her day care operation. Therefore, Ms Dorsey's operation would be added to the attached list, and be subject to Fire Department inspections.
