**NOTICE OF PUBLIC HEARING**

Please take notice that on April 23rd at 7:00 P.M., or as soon as the agenda permits, in the City Council Chamber, 409 South Main Street, Harrisonburg, Virginia, the Harrisonburg City Council will conduct a public hearing, pursuant to Section 4-2-17 of the Harrisonburg City Code, as amended, concerning the following five (5) requests by non-profit corporations for exemption from local real estate and personal property taxation:

Way to Go Inc, 317 South Main Street, Harrisonburg, VA 22801. The assessed value of the personal property for the year 2018 was \$9,916. The taxes assessed by the City for the year 2018 were \$254.12; for the year 2017, \$0; and for the year 2016, \$0.

Harrisonburg Gift & Thrift Shop, Inc, expansion at 731 Mt Clinton Pike, Harrisonburg, VA 22802. The assessed value of the applicant real property (Tax Map 47 M 3T) for the year 2018 was \$1,514,300. The taxes assessed by the City for the year 2018 were \$12,871.55; for the year 2017, \$0; and for the year 2016, \$0. The assessed value of the personal property for the year 2018 was \$13,800, and the taxes assessed by the City for the year 2018 were \$292.56; for the year 2017, \$0; and for the year 2016, \$0.

Madison Automotive Apprentices Inc, 1070 Virginia Ave, Harrisonburg, VA 22802. The assessed value of the personal property for 2018 was \$28,265. The taxes assessed by the City for the year 2018 were \$718.13; for the year 2017, \$0; and for the year 2016, \$0.

Center for Health and Human Development, 748 Madison St, Harrisonburg, VA 22802. The assessed value of the applicant real property (Tax Map 41 M 15 and Tax Map 40 T 18) for the year 2018 was \$148,500 and the taxes assessed by the City for the year 2018 were \$1,262.25; for the year 2017, \$1,230.80; and for the year 2016, \$1,129.44.

Center for Health and Human Development, 851 Madison St, Harrisonburg, VA 22802. The assessed value of the applicant real property (Tax Map 041 K 5 6) for the year 2018 was \$144,100, and the taxes assessed by the City for the year 2018 were \$1,224.85; for the year 2017, \$1,218.05; and for the year 2016, \$ 1,117.74.

Public comments on the proposed exemptions are invited, and all citizens shall have an opportunity to be heard.
