RE: Personal Property Tax Exemption for Blue Ridge Free Clinic, Inc

<u>Summary:</u> In January 2023, an application was received from Blue Ridge Free Clinic, Inc for personal property tax exemption at 831 Martin Luther King, Jr. Way.

<u>Background:</u> The Constitution of Virginia allows for specific local tax exemption. Prior to January 1, 2003, the General Assembly passed bills exempting a 501(c)(3) organization from local taxation and as of January 1, 2003, local elected officials were given the authority to make the determination. Harrisonburg City Code §4-2-17 addresses local real and personal property exemption. The above stated entity is requesting exemption under this code.

Key Issues:

1. Since 2021, Blue Ridge Free Clinic has been offering healthcare, medication assistance, urgent dental care and needs-based navigation services to our neighbors in need. These services are being provided by volunteers and donors. The clinic's primary goal is provide long term, sustainable and affordable healthcare for all! Blue Ridge Free Clinic, Inc has paid \$, \$568.16 in personal property taxes for FY23. The 2023 assessment for personal property is \$41,636 and at the current tax rate of \$2.12 per \$100 would generate \$ 882.68 of personal property revenue in FY24.

Environmental Impact: None

<u>Fiscal Impact:</u> If the exemption is granted the reduction in personal property tax revenue would be \$ 882.68 at the current personal property tax rate.
