1.	ELECTORAL BOARD MEETING MINUTES

Harrisonburg Electoral Board Meeting August 6, 2015

In Attendance:

Greg Coffman, Chairman; Bill Ney, Vice Chairman; Sandra Price-Stroble, Secretary; Deborah Logan, Registrar; Diane Nardi, Assistant Registrar: Donna Wimer, Assistant Registrar.

Guests Present: Deb Stevens-Fitzgerald, HDC Chair: Mac Nichols, HRC Chair; Josh Humphries, Chairman of JMU SGA Legislative Committee.

Chairman Coffman called the meeting to order at 1:05 p.m. Visitors were welcomed.

Minutes

The minutes of the July 8, 2015 meeting were approved as presented.

Public Comment Period: No comments from the public.

Business Meeting

Registrar Debbie Logan distributed the redrawn maps for the proposed on campus precinct at JMU. Chairman Coffman shared with the Board members that after review by the City Attorney, Chris Brown and GIS Department, it is necessary to move the voters in the Hillcrest neighborhood from the Spotswood Precinct to the proposed new JMU Precinct. As Mr. Brown had commented at the last Council meeting, when redrawing lines for voting precincts there are factors that have to be considered such as natural lines such as railroads, whether or not any neighborhood would be "orphaned" by the establishment of the new precinct and the precinct would have to be contiguous. When considering these factors, the new Precinct would need to include the approximately 200 voters in the Hillcrest neighborhood area in addition to the on-campus students with an 800 South Main Street address.

Mr. Coffman asked Mrs. Price-Stroble if she would withdraw her previous motion that was passed at the last meeting in order that a new motion could be made that would be aligned with the guidelines for establishing this new precinct. After discussion and Mrs. Price-Stroble expressing her concerns that this would not change the time line for the ordinance preparation and public hearing, Mrs. Price-Stroble withdrew the previous motion and made another motion that would be in keeping with the recommendations of the City Attorney and the GIS Department.

Mrs. Price-Stroble made the following comments and motion:

Based on the information received from GIS and the City Attorney, the Electoral Board withdraws the previous recommendation regarding the proposed JMU Precinct that was submitted to Council.

The Board replaces that recommendation with the revised recommendation as follows:

The Harrisonburg Electoral Board recommends to City Council that a voting precinct be established on the campus of JMU that would include students with the 800 South Main Street address and including the Hillcrest neighborhood bordering South Main Street, Port Republic Road and the JMU Campus

The motion was seconded by Bill Ney and the motion was passed 2 to 1. (Yes – Ney & Price-Stroble No-Coffman).

Registrar's Report

Debbie Logan reported that the new voting machines are ready to be delivered whenever we move to the new office. The old machines have been returned. The next steps are to receive the equipment, perform acceptance testing and train Board, Technicians and Office Personnel.

The Board decided by consensus to order ballots this year from Print Elect instead of Ben Franklin. We have purchased the new machine from Print Elect and would feel more comfortable ordering the ballots from them as well since this is our first year using the new machines. The Board also agreed to have the Registrar order enough ballots for 75% of the total active voters.

Debbie reported that Myron Mclees from ELECT would like to talk with the Board at some time regarding the offer to finance the cost of the new Precinct if approved by Council. As this is a new procedure, Myron would like to review the procedure to be followed. It was suggested that Myron speak with Chris Brown, City Attorney, as well.

The packet of materials presented from the Registrar and Electoral Board members will be uploaded to the City Website and available for the public to review on August 17 prior to the public hearing at the August 25 City Council meeting.

Mr. Coffman thanked the staff and the Board for their diligence in preparing these materials in a timely manner at the Council's request.

The Registrar reviewed the Confirmation process with the Board members.

Pros and Cons Reports Regarding Proposed JMU Precinct

Mr. Ney and Mrs. Price-Stroble presented their thoughts regarding the pros of establishing a Precinct on campus. Mr. Coffman presented a list of Cons. These reports are included with the minutes as Attachments One and Two.

The Public meeting was adjourned at 2:40 p.m. to go into closed session.

Closed Session: 2:50 p.m.

The motion was made by Bill Ney, seconded by Sandra Price-Stroble and approved to adjourn the Public Session and convene in Closed Executive Session according to the authority 2.2-371-A1 (Personnel) of the Code of Virginia.

Open Session

The Board reconvened in Open Session. A Roll Call vote was taken as required by 2.2-3712-D of the Code of Virginia to Certify that during the Closed Session only business as allowed according to the authority of 2.2-371-A1 (Personnel) was discussed.

Coffman-yes, Ney-yes, Price-Stroble-yes.

Future Meeting

The next regularly scheduled monthly meetings will be held on the First Thursday and the Third Wednesday at 2:00 p.m. unless otherwise announced. The next meeting will be on August 19, 2015 and will be a work session to review the JMU Precinct information submitted to Council and to prepare for the November General Election.

Attachment # 1 for Draft Minutes 8/6/15

Points in Favor of Establishing a Precinct on JMU Campus

- The Electoral Board should be encouraging increased voter participation. Adding a precinct to the campus of JMU will provide easier accessibility to the oncampus students. The potential pool of on campus housing voters is approximately 6000 according to the administration of JMU.
- Harrisonburg has a low percent voter turnout. Easing accessibility to the polling location could help to increase the student participation in voting and help the overall percentage of voter turnout for the City.
- Typically the majority of students living in on-campus housing are freshman and new to their community. There are hurdles unique to freshman college students who are just becoming familiar with the geography of their new community. Students can become more aware and feel more ownership of local laws and practices if they become more engaged in their community by voting.
- At the present time we do not have any data to give a realistic picture of what increase in student voter participation could take place if a precinct is located on campus. The only way we will know the impact of having an on-campus precinct is to establish the precinct and then compare data to the current turnout data.
- There is often confusion for students when registering to vote. This can result in students finding they are not on the pollbook. When this happens, students are asked to step aside and a Chief Officer has to be available to offer a Provisional Ballot. There tends to be more backup and waiting when there is more need to cast a Provisional Ballot. Having a larger number of first time voters at the same on-campus precinct could help the situation for other voters at the current Spotswood Precinct to avoid delays. At the present time a number of the Provisional Ballots cast are from students.
- JMU is willing to reimburse the City for costs related to establishing a new precinct on campus and for the yearly costs therefore this precinct could be established without cost to the city and its taxpayers.
- In 2011 over 3200 students registered to vote. Less than 200 voted. There should be an increase in the voter participation by having a precinct on campus.
- Hopefully by helping to educate and facilitate the vote by young people impacted by adding a conveniently located more accessible Precinct on campus, we can begin a process that they will carry with them in the future. In supporting JMU's Civic Engagement Initiative, we are encouraging the students to become voting citizens in Harrisonburg where they will also engage with pride and eagerness in their community and become more aware of the local government processes.

Attachment #2 for Draft Minutes 8/6/15

Points Against Establishing a Voter Precinct on JMU Campus

- The issue is not about "voter rights" but "voter privilege". JMU students are already voting in the city at the Spotswood Elementary School precinct.
- Establishing a distinct and separate precinct on JMU campus sets an outstanding precedent, i.e. if you can pay for it the city will do it. Objections to consider:
 - o Could a neighborhood request their own precinct if they agreed to pay for it?
 - Could another institution, VMRC perhaps, request a precinct if they agreed to pay for it?
 - Instead of fostering JMU's intended plan to interface more with the community, this request actually provides more exclusion and separation for the JMU community.
 - We are providing more convenience for JMU students than we provide for our own registered voters.
 - Other registered voters will view this as another accommodation to JMU rather than an action based on what is most appropriate for the city voters.
- The impression has been given that most state colleges\universities have their own polling place on campus exclusively for students, the reality is that only one state-owned college\university does: VPI. Liberty University, which is a private university, also has its own precinct exclusively for students. Two other state universities, UVA and George Mason, have an on-campus precinct but they are for students and local residents, not just students.
- While some registered voters in our precincts have to travel from 1.2-3.0 miles to get to
 their respective polling place, JMU students from the farthest point on campus
 have to travel only 0.8 miles. In fact, on-campus students are closer to their
 current precinct than the majority of city voters are to theirs.
- With a precinct selectively placed on JMU's campus for its students, the impact on an
 election in which a JMU professor or employee is running for local office has the
 potential of wresting the control of City Council from the local registered voters
 to the JMU students. Additionally, a JMU student could win a seat on City
 Council based on JMU votes entirely.

- Based on past voting records, the request would not have merited the Electoral Board's investigation.
 - o In 2014, 173 of 2240 (8%) registered on-campus students voted.
 - o In 2013, 263 of 2250 (12%) registered on-campus students voted.
 - o In 2012, 883 of 2320 (38%) registered on-campus students voted in the Presidential Election
- Currently, city precincts are established for a maximum of 5000 registered voters. In 2014, there were 2240 on-campus registered voters at JMU. Removing that many from the polls at Spotswood would necessitate a redistricting of all the polls in the city. Since this will probably need to be repeated after the 2020 census, the question arises as to why it should be done twice in 4 years.
- The impact on local elections from the JMU campus is significant. While past voting records indicate only a yearly average of 330 on-campus students voting, many local elections have been shifted by less than 150 votes.
- Instead of the time and expense of a separate precinct on JMU's campus, busing can be provided for the students to their polling station, Spotswood Elementary School, at no expense to the students.

Chairman Coffman called the meeting to order at 2:00 p.m. Visitors were welcomed.

Minutes

The minutes of the June 17, 2015 meeting were approved as presented.

Public Comment Period:

Phyllis Coulter and Jerry Coulter individually commented on the Electoral Board's consideration of establishing a precinct on the JMU campus. Both Mr. and Mrs. Coulter expressed they did not believe there is a need for this precinct to be established.

Chairman Coffman thanked the Coulters for their attendance.

Business Meeting

Chairman Coffman welcomed the representatives from James Madison University and thanked them for attending the meeting the today, at the Electoral Board's request, to address questions we have regarding the establishment of a voting precinct on the JMU campus.

Prior to the meeting, the Electoral Board submitted the following questions to JMU regarding their offer to share responsibilities if a precinct would be established on campus:

- 1. How many students live at 800 South Main Street?
- 2. There would be a cost estimated between \$15,000.00 and \$20,000.00 to start a new precinct. What part of this cost would JMU be willing to provide?
- 3. A voting precinct needs to be a secure facility with handicap access and adequate parking. We would need control over it from 6:00PM. on the eve of the election until 12:00AM. after the election. This facility must be available for all national, state, and local elections and primaries. Is there a facility available on camus.
- 4. Is it possible for the Registrar's Office to have an office on campus each fall to help students with the Voter Registration process and Absentee Voting?
- 5. Would JMU be willing to share the voting precinct with voters who live in the nearby community?
- 6. What is the possibility of JMU supplying buses to transport students to the present voting precincts?

The members of the Electoral Board asked the representatives from JMU these questions and other follow-up questions.

In summary:

- 1. Mr. Charles King responded that there are approximately 6000 students living on campus. (The new Grace Street complex would add an additional 500 students, however this location would be in another voting precinct according to the current precinct lines.)
- 2. JMU would be willing to reimburse the City for the start-up costs of a precinct on campus and the yearly operational costs.
- 3. JMU could provide a secured, handicapped accessible location on campus with amble parking that would meet the required hours needed prior to and during the election period.
- 4. It would be possible to provide a location for a satellite office during the 45 day period prior to the election.
- 5. JMU would be supportive of sharing the precinct with voters from neighborhoods surrounding the campus.
- 6. This question was not discussed at the meeting.

Josh Humphries from the SGA at JMU shared that establishing the voting precinct on campus would be in keeping with the JMU Strategic Plan which has an emphasis on Student Civic Engagement in the community.

After this question/answer period, Chairman Greg Coffman expressed his concerns as to why he did not consider this a good idea to establish a new Precinct on Campus. Mr. Ney expressed the number of potential voters was significant at 6500 in on-campus housing. Mrs. Price-Stroble shared with Mr. Coffman that the other Board members had as yet refrained from expressing an opinion in this matter. She stated that it appeared to her that this was moving into more of a debate period and discussion of the pros and cons of establishing the precinct rather than just a gathering of information and she wished to offer a motion and then have opportunity to continue that discussion/debate period.

As a preface to making a motion, Mrs. Price-Stroble said she did not agree at this time with moving voters in neighborhood communities from their voting precinct in order to balance out numbers. She expressed that redistricting would be done again after the next census and we could consider that option at that time and determine whether having a precinct on campus had improved the student participation level in elections in Harrisonburg. Price-Stroble did not think we have adequate information under the current voting locations to determine how the student participation might be impacted if the voting precinct was on campus.

Board Member Price-Stroble made the motion that the Electoral Board recommend to City Council that a new Precinct be established on the Campus of JMU for all students living in On-Campus Housing who are registered voters in the City of Harrisonburg. Board Member Ney seconded the motion. The vote was 2 in favor and 1

opposed. Mr. Ney and Mrs. Price-Stroble voted in support of the motion and Mr. Coffman voted against the motion. The motion was passed.

Closed Session:

The motion was made by Bill Ney, seconded by Sandra Price-Stroble and approved to adjourn the Public Session and convene in Closed Executive Session according to the authority 2.2-371-A1 (Personnel) of the Code of Virginia.

Open Session

The Board reconvened in Open Session. A Roll Call vote was taken as required by 2.2-3712-D of the Code of Virginia to Certify that during the Closed Session only business as allowed according to the authority of 2.2-371-A1 (Personnel) was discussed.

Coffman-yes, Ney-yes, Price-Stroble-yes.

Board To Talk Precinct With JMU Officials

HARRISONBURG - The Harrisonburg Electoral Board has input from the Voter Registrar on the merit of a new precinct for James Madison University students. But members are not ready to make a recommendation to City Council. On Wednesday, the board voted to meet with city officials and JMU representatives by its July meeting about creating a precinct either exclusively for on-campus students or one that also encompasses surrounding neighborhoods.

The next meeting date has not been set, board member Sandra Price-Stroble said.

Last month, City Council asked the board to make a recommendation on the proposal, but the elections panel decided to wait until it could talk with more stakeholders.

"One of the things that has bothered me from the very beginning with this is the lack of actual involvement by the university," board Chairman Greg Coffman said.

He said that he did not consider the board's communication with student Josh Humphries and the JMU Student Government Association as university involvement.

Humphries originally submitted the request on behalf of SGA in March, and the board has treated the issue as an ongoing agenda item.

In a report to the board Wednesday, Registrar Deborah Logan said a new precinct for on-campus students is not justified given historically low student-voter turnout and the current equity of Harrisonburg's seven precincts for all city voters.

JMU students living on campus can register to vote in the Spotswood precinct, which is geographically the smallest in the city.

"Basically, you're talking about my very smallest precinct and splitting it in half," Logan said.

Each of the seven precincts saw voter turnout of 1,800 to 2,300 during the 2012 presidential election and between 800 and 1,100 for the 2014 gubernatorial election. Precincts are designed for a maximum of 5,000 voters, and in last year's election, only 173 of 2,240 voters registered on JMU's campus went to the polls, Logan said.

She added that those registered on campus are mostly inactive because they have since moved off campus and not updated their information.

Humphries cited accessibility as the reason to establish an oncampus polling place for students, but Logan said Wednesday that the distance from JMU to Spotswood Elementary School is less than a mile.

By comparison, she said, in the other precincts, voters must travel as far as 1.2 to three miles.

On-campus students at Eastern Mennonite University and residents of Virginia Mennonite Retirement Community, for example, both travel farther to vote in Harrisonburg than JMU students.

"I'm just trying to look at all citizens the same," Logan said.
"Take away where they are, take away what they do, all citizens have equal access to getting to the polling places."

She asked that instead of a new precinct, the city make a greater investment in educating students on campus about their voting options, including absentee ballots.

In a March 31 letter to the Electoral Board from Maggie Burkhart Evans, executive assistant to JMU President Jonathan Alger, the administration gives its support for the creation an on-campus precinct for students.

"Understanding that expenses may be incurred in this process, James Madison University is willing to partner with the City to explore a plan for sharing potential costs," the letter says.

Logan told the board that it would cost approximately \$20,000 in startup costs and about \$4,000 annually to establish a new voting precinct.

"Should the measure pass City Council, the administration will gladly meet with members of the Electoral Board and City staff to discuss plans for an on-campus voting location," Burkhart Evans writes.

Humphries, 21, said after the board's meeting Wednesday that he was pleased with the progress on the issue.

"As far as the numbers go, I mean ... they could be better," he said of the student turnout. "But I think we need to be deciding that if we're getting a precinct on campus, I believe that that would inherently turn out more students to vote."

Harrisonburg Electoral Board Meeting June 17, 2015

In Attendance:

Chairman Coffman called the meeting to order at 2:00 p.m.

Minutes

The minutes of the May 26, 2015 meeting were approved as corrected.

Public Comment Period:

Chaz Evans-Haywood, Clerk of the Circuit Court, addressed the Board regarding the need to educate college students that registering to vote in Harrisonburg also means they could be summoned for jury duty. Mr. Evans-Haywood expressed concern that students often do not receive their notice for jury duty because they have not updated their address or if it is received they sometimes disregard it. He is concerned that this goes on their record as breaking the law if they do not report for duty.

Board member Ney asked if this was also applicable to students registering who registered in other areas. Board member Price-Stroble asked if the same concerns would not also apply to any other registered voter and commented we needed to be cautious that we did not single out any particular voter group. Also she expressed concern that in educating the student voter regarding the possibility of being summoned for jury duty we do not influence the voter's decision as to whether they want to register to vote in Harrisonburg or to vote absentee where they reside when not attending college.

Chairman Coffman thanked Clerk Evans-Haywood for addressing the Board.

Monthly Report from Registrar

Registrar Debbie Logan reported that 9 new voting machines have been purchased. The funds to purchase are from the 2014-2015 fiscal year and the fiscal year 2015-2016. Delivery should be the end of July. Mrs. Logan purchased the Gold Level agreement for training, setup and support. The \$1800 cost includes set-up in exchange for our old machines.

The Registrar reported information to the Board regarding possible location of a voting precinct on the JMU Campus. After questions to Mrs. Logan and Board discussion, Board Member Ney made the motion that the Electoral Board request a meeting with a representative from JMU and invite a representative from City Council to attend. Report from Registres 6-17-15 Fie Corg

The city of Harrisonburg is currently divided into 7 precincts established after the last census

These 7 precincts are equitable in size and centrally located for voters

Looking at our largest election (Presidential 2012) – voter turnout was between 1800 and 2300 voters in each precinct.

Our second largest election (Gubernatorial 2014) - voter turnout was between 800 and 1100

These numbers are well below the 5000 voter limit that calls for a new precinct.

Our small precincts have made the city elections very efficient with no more than a 15 minute wait time during our last presidential. All citizens of Harrisonburg are being treated equally.

As Registrar I have been asked to comment on the possibility of adding a new city precinct on the JMU campus for on campus student voting only.

This would cost the taxpayers of Harrisonburg \$20,000 in start up costs and a significant annual cost (about \$4000 per election) to maintain and staff each election.

The numbers just don't support creating a precinct for campus voters. In 2014 of the 2240 registered voters on campus only 173 voted. Most of the 2240 voters are labeled inactive meaning they have moved from that location. This population is transient and the numbers change every year as the majority of the students move off campus after their freshman year.

The argument that on campus residents have limited access to transportation does not hold up – bus transportation provided by the city is available and additional scheduled buses can be added for Election Day. These voters are much closer to their precinct than the majority of the citizens of Harrisonburg.

Students do have the option of voting absentee. In fact it is the first and most widely used reason on the absentee application. The ballot is mailed directly to the student who votes it and places it back in the mail without ever having to leave campus.

JMU has expressed a strong desire to become involved citizens in the city of Harrisonburg. Why would you want to isolate them in the voting process rather than engage them in community by participating and voting alongside community members?

In my professional opinion and as a steward of the taxpayer's money for the city of Harrisonburg, I feel that the current voting precincts serve all our citizens equally and fairly.

APPOINTMENT OF GENERAL REGISTRARS

The term of the registrar in office expires on June 30, 2011. The electoral boards must meet in either May or June to appoint the locality's general registrar for a four-year term beginning July 1, 2011. Some electoral boards will choose to reappoint the current registrar and some will be appointing a new registrar.

§ 24.2-109 and §24.2-110 addresses appointment, qualifications and term of the general registrar as well as vacancies and certain prohibitions (see below). Please refer to this section of the code as well as Chapter 3 of the General Registrar and Electoral Board Handbook (GREBook) when appointing the general registrar for your locality.

§ 24.2-110. Appointment, qualifications, and term of general registrar; vacancies; certain prohibitions.

Each electoral board shall meet in the month of May or June in 2007, and every four years thereafter, and shall appoint a general registrar, who shall be a qualified voter of the county or city for which he is appointed. However, in the case of a city that is wholly contained within one county, the city electoral board may appoint a qualified voter of that county to serve as city general registrar. General registrars shall serve four-year terms beginning July 1, 2007, and each fourth year thereafter, and continue in office until a successor is appointed and qualifies.

The electoral board shall fill any vacancy in the office of general registrar for the unexpired term. The electoral board shall declare vacant and fill the office of the general registrar if the appointee fails to qualify and deliver a copy of his oath to the secretary of the electoral board within 30 days after he has been notified of his appointment.

No general registrar shall hold any other office, by election or appointment, while serving as general registrar; however, with the consent of the electoral board, he may undertake other duties which do not conflict with his duties as general registrar. General registrars shall not serve as officers of election. The election or appointment of a general registrar to any other office shall vacate the office of the general registrar.

No general registrar shall be eligible to offer for or hold an office to be filled by election in whole or in part by the qualified voters of his jurisdiction at any election held during the time he serves as general registrar or for the six months thereafter.

The electoral board shall not appoint to the office of general registrar any person who is the spouse of an electoral board member or any person, or the spouse of any person, who is the parent, grandparent, sibling, child, or grandchild of an electoral board member.

No general registrar shall serve as the chairman of a political party or other officer of a state, local or district level political party committee. No general registrar shall serve as a paid or volunteer worker in the campaign of a candidate for nomination or election to an office filled by election in whole or in part by the qualified voters fhis jurisdiction. The restrictions of this paragraph shall apply to paid assistant registrars but shall not apply to unpaid assistant registrars.

In response to your letter, the Harrisonburg City Electoral Board also agrees that having an on-campus voting precinct would benefit the civic engagement of the students. Statistics show that if there is a precinct on campus that there would be a likely voter increase of 15%. But, this would not be enough to justify a voting precinct solely for the JMU students living in the campus dormitories. It is of our opinion that the dilleres voting precinct should also include the residential areas of Hillandale, Williams For est Hills, and Purcell Park along with the JMU Dormitories. This would insure a higher voter turn-out for all elections.

A voting precinct has to be a secure facility with handicap access and parking. We would need to have control over it from 6:00 PM. on the eve of the election until 12:00 AM after the election. As you know that there are elections on the first Tuesday of November every year. There are also primaries and special elections that may be held at any time. If there is an on-campus precinct, it must be available for every election. We also hope that JMU would be able to help offset some of the approximately \$7,500.00 cost of having an additional voting precinct.

The electoral board and the registrar's office strive to make it easier for everyone to pursue their right to vote. We would like to have an office on campus during the beginning of the Fall Semester to be able to

register new students and also help students who are already registered in other localities in Virginia to apply for absentee ballots. Students have the right to vote in Harrisonburg; but they must choose themselves whether to vote here or in their hometowns.

If JMU agrees to these conditions, The Harrisonburg Electoral Board would recommend to the City Council that they realign the voting precincts and add a new precinct on the JMU campus.



Dear Harrisonburg Electoral Board,

Over the last several months, I've been gathering information and soliciting feedback regarding the establishment of a voting precinct on James Madison University. This precinct would only be for those students living on campus in a dormitory; not off campus students. This is primarily due to concerns over how we would decide which off campus complexes to include in the precinct as well as not wanting to remove community members from their existing polling locations.

In asking for this precinct, we are not going into uncharted waters. Other colleges and universities within the Commonwealth of Virginia also have on campus voting precincts, including; University of Virginia, Virginia Tech, George Mason University and Liberty University.

This initiative also is supported by the JMU administration. JMU is a university that is "committed to preparing students to be educated and enlightened citizens who lead productive and meaningful lives," as well as seeking to "be the national model for the engaged university: engaged with the world and ideas." The establishment of a voting precinct is directly in line with those statements. We are working to be sure that students are aware of the civic process and are informed about the decisions they're making. According to the Campus Election Engagement Project, simply adding a precinct to a campus will increase turnout by 17 percent.

One thing this initiative is not about is partisan politics. Throughout this process, the main criticism is the fear that the "highly liberal" campus of James Madison will sway elections in Harrisonburg. This simply is not true. According to the Office of Institutional Research, the entering freshman class identified themselves as 36% Moderate, 33% Conservative, and 31% Liberal. I believe in enfranchising more people, and reducing the barriers for civic participation, regardless of political affiliation. This is a great way to get more citizens involved in the civic process at a minimal cost.

Finally, the students who are living on campus are the newest and most vulnerable members of this community. It is unlikely that these students, new to this area, are likely to go off campus during their first year as a student. We are trying to remove as many of the logistical barriers to participating in the democratic process as possible. Please feel free to contact me at humphrjm@dukes.jmu.edu with any questions.

After deliberating, should the Electoral Board find this to be a favorable proposal, I would like to ask that the Electoral Board make a recommendation to City Council. After speaking with members of council that seems to be the best course of action to take at the present time. When feasible the Closed Session part of a meeting would be held toward the end of the agenda in consideration of members of the general public who may be in attendance.

Roles and responsibilities of Board members were discussed. The Vice-Chairman, Bill Ney, will be the Board contact to work with the Equipment/Election Coordinator, Bill Blessing. Sandra Price-Stroble will update the Officer of Election Training Program. The designation of a spokesperson was deferred to a later time.

The Board addressed the need to recruit Officers of Elections. Each Board member will assist with recruitment. Efforts will be made to contact civic organizations and local colleges regarding the ongoing need for Officers. A list of the currently approved officers who have accepted appointment will be posted in the Registrar's Office.

The Equipment Security Verification Form has been updated in January 2015 by the previous Board. New equipment requests have been included in the 2015 budget. Two new Accuvote Scanners will be purchased prior to July 1, 2015 as approved in the 2014 budget. If the 2015 budget is approved, seven more Accuvote Scanners will be purchased. Any new equipment purchased will need to be reported in the Security Plan when updated.

Deborah Logan, Registrar, reviewed some legislative changes in the Election Code. Absentee Ballot responsibility is now back in the hands of the Registrar. ID legislation

et octes en ottes optil mother puntur passed by the General Assembly included a requirement that Photo ID is required for persons voting absentee. VRAB has basically opposed this legislation and it is possible it will be vetoed by the Governor.

The Registrar and Board discussed the status of the new Administrative Building and office space for the Registrar's Office. We will continue to advocate for rotated seasonal sharing of the office joining the Commissioner of Revenue and Registrar's Offices and revisit the concerns again with City Staff when the move to the new building is closer at hand.

The Registrar's Review for Reappointment will need to be completed this year. The Board will go into Closed Session during the April meeting to begin the personnel review process.

Sandra Price-Stroble referred to the letter the Board members received from Josh Humphries, who represents the JMU Student Government. In his letter he requests that the EB members study the feasibility of a voting precinct being located on the JMU Campus and consider making a recommendation to the Harrisonburg City Council. After review of the Resolution on a different issue that Mr. Humphries presented to the previous Board in November, Sandra made the motion that Mr. Humphries be invited to attend the April Board meeting to make a presentation to the Board regarding locating a Voting Precinct on the JMU campus. The motion was seconded by Bill Ney and passed.

Chairman Coffman asked if there was any New Business to be brought before the Board. Mr. Ney noted that an issue had been reported to the Registrar who in turn brought it to the attention of the Electoral Board. The issue reported involved a question regarding the eligibility of a current School Board member to serve the District to which he/she was elected in 2012. The question of eligibility is in regard to residency issues. Mr. Ney stated that at the direction of the Electoral Board, the Registrar has referred to the matter to the City Attorney. The City Attorney has referred the matter to the School Board attorney. Should the Electoral Board be asked for a statement it will be the position of the Board or its individual members to state that this matter was referred to the City Attorney and no longer up to us to take any further action at this time. The Board members also agreed that we would not confirm or deny any School Board Member's name associated with this report.

With no further business, the meeting was adjourned at approximately 11:30 a.m.

City of Harrisonburg Electoral Board Meeting of February 18, 2015

Present: Sandra Price-Stroble, Jim Gilchrist, Penny Imeson, GR Debbie Logan.

Guest: Bill Ney

Sandra called the meeting to order at 3:04 pm.

Jim moved to approve the minutes of January 22nd as presented. Bill Ney noted misspelling and Penny corrected. The minutes were approved unanimously.

Debbie Logan presented the GR Report:

- 1. State Budget for voting equipment did not pass, but Debbie submitted 2015-16 budget line of \$70,000 per Dominion's higher quote. With no state funding there will be no vendor mandate. Debbie provided PrintElect quote of \$50,540, a significant savings. EB discussed situation and recommended that Debbie advise City that costs for new machines dropped. Jim emphasized critical need for new machines should be clarified to City.
- 2. Staff has reviewed files/documents per Document Retention schedule. Everything is up-to-date with expired paperwork ready to be picked up for destruction.
- 3. Only 52 of 143 OEs responded to call for renewal. GR office sent email reminder last week. Jim expressed concern that OE roll is an inadequate pool for 2016 election year. Debbie recommended that Debbie see opportunities to speak to clubs and civic groups. EB confirmed that the list sent to Party charis was the approved list. The ELECT deadline to identify OE list was met when EB gave GR approval to send letter in January. Diane Nardi suggested placing a notice in City employee newsletter. Jim suggested creating a formal recruitment plan. Debbie is frustrated by lack of support from political parties. Penny suggested requesting an announcement at First Friday lunches. Bill asked if the information is on the website (yes). Sandra suggested a notice at the public library.



- 4. EB discussed response to inquiry from Chris Kent, a reporter for The Breeze (JMU newspaper). Both Sandra and Penny deferred his questions to Debbie at different times. Debbie did speak with him. His questions were mostly hypothetical regarding a potential JMU-only precinct. Debbie referred him to City Council as the body with power to create precincts and to Richmond as the power to change legislation regarding where voters vote. After speaking with Chris, Debbie wants education on campus.
- 5. Otherwise, quiet in office. Judy is in Florida in February. Greta works one day per week filing.
- 6. EB reviewed EB Annual Meeting plans and reservations at the Homestead. Bill and Sandra confirmed they are attending.
- 7. Debbie asked Ande Banks about accessibility in New City Hall and during the conversation, Ande stated that Council Chambers would NOT be available for Elections due to the 45 day rule, but said GR/EB could use closet. Richard Baugh and Bill Ney appeared after Ande left. When Debbie filled them in, Richard stated that Council could do without the chambers for that time period.

New Business:

Penny revisited formal plan of OE recruiting, specifically the educational outreach to groups. Bill suggested split days might encourage more recruits. Debbie reported that most localities try to avoid split shifts to minimize negative scenarios.

Penny moved to enter closed session pursuant to VA Code section 2.2-3711 for discussion of Personnel. EB ended closed meeting and certified only personnel issues were discussed by roll call: Sandra- yes, Jim- yes, Penny – yes.

City of Harrisonburg Electoral Board Meeting of January 22, 2015

Present: Sandra Price-Stroble, Jim Gilchrist, Penny Imeson, GR Debbie Logan. Guests: Bill Ney, Joshua (Josh) Humphries, JMU SGA Legislative Action Committee

Sandra called the meeting to order at 9:07 am. Jim moved to approve the amended minutes of December 11th, 2014. Sandra seconded and the motion carried.

Joshua Humphries presented a JMU SGA Resolution to work with EB and ELECT and Student Senate to clarify election lay, especially with regards to online and paper registrations. Joshua is working internally at JMU to be sure oncampus registrations will have dorm names and is also looking into P.O. boxes to correlate to dorms. EB stated it is happy to receive communication on and support such efforts. (NOTE: According to Josh, 911 calls go to dorm,. Not physical address.)

Josh is also working on a new precinct for on-campus students only. According to Josh, on-campus P.O. boxes are only for students paying room and board. Josh working to get USPS address change form provided to students when they finish their first year.

Debbie is considering a satellite GR office on JMU campus based on Radford model. Jim asked about reasons for oncampus precinct. Josh responded the precinct (which would most likely be at the Convocation Center) would 1.) increase student turnout by 17%; 2.) make it simple for students to know where to vote; 3.) bring JMU in line with the other VA Big Four; 4) would make Dems busing unnecessary.

With regards to TurboVote: JMU is always looking for ways to make it easier for students to vote. Josh spoke with TurboVote about problems with the system, for example the misleading "Congratulations" message seen in 2014. Debbie then reported that eight (8) TurboVote absentee votes for the November 2014 election arrived in December 2014.

Debbie presented NVRA Purge list with copies for local Party Chairs. 578 people were removed from local lists. Discussion ensued. GR reported that all requests for oaths and information were mailed to 143 OEs, but there were few responses. Debbie is surprised by the number of "no" responses. Debbie reported legislative initiative tyo return AB duties to GRs where tasks are now carried out, in most instances.

EB reminded of State Board Training: July 27-28-19, location tbd. At present, EB/GR anticipate November election, although there are rumors of primary.

Debbie submitted budget to City by January 30 deadline. There were no major changes, except \$70,000 to purchase seven (7) new voting machines. We now use PrintElect. Debbie saw Dominion machines which don't work with AccuVotes. Since State is leaning toward one vendor, Debbie used the more expensive Dominion costs in her budget.

New City Hall: According to plans, office will move in September. Debbie stated she will NOT move if date is pat the 45-day rule. Sandra wondered about talking to new Mayor Chris Jones about the new City Hall floor plans. Penny recommended waiting until hard hat tours.

Penny moved to enter closed session pursuant to VA Code section 2.2-3711 for discussion of Personnel. EB ended closed meeting and certified only personnel issues were discussed by roll call: Sandra- yes, Jim- yes, Penny — yes.

Sandra adjournedthe meeting at 11:15 am.

Points in Favor of Establishing a Precinct on JMU Campus

- The Electoral Board should be encouraging increased voter participation. Adding a precinct to the campus of JMU will provide easier accessibility to the oncampus students. The potential pool of on campus housing voters is approximately 6000 according to the administration of JMU.
- Harrisonburg has a low percent voter turnout. Easing accessibility to the polling location could help to increase the student participation in voting and help the overall percentage of voter turnout for the City.
- Typically the majority of students living in on-campus housing are freshman and new to their community. There are hurdles unique to freshman college students who are just becoming familiar with the geography of their new community. Students can become more aware and feel more ownership of local laws and practices if they become more engaged in their community by voting.
- At the present time we do not have any data to give a realistic picture of what increase in student voter participation could take place if a precinct is located on campus. The only way we will know the impact of having an on-campus precinct is to establish the precinct and then compare data to the current turnout data.
- There is often confusion for students when registering to vote. This can result in students finding they are not on the pollbook. When this happens, students are asked to step aside and a Chief Officer has to be available to offer a Provisional Ballot. There tends to be more backup and waiting when there is more need to cast a Provisional Ballot. Having a larger number of first time voters at the same on-campus precinct could help the situation for other voters at the current Spotswood Precinct to avoid delays. At the present time a number of the Provisional Ballots cast are from students.
- JMU is willing to reimburse the City for costs related to establishing a new precinct on campus and for the yearly costs therefore this precinct could be established without cost to the city and its taxpayers.
- In 2011 over 3200 students registered to vote. Less than 200 voted. There should be an increase in the voter participation by having a precinct on campus.
- Hopefully by helping to educate and facilitate the vote by young people impacted by adding a conveniently located more accessible Precinct on campus, we can begin a process that they will carry with them in the future. In supporting JMU's Civic Engagement Initiative, we are encouraging the students to become voting citizens in Harrisonburg where they will also engage with pride and eagerness in their community and become more aware of the local government processes.

Points Against Establishing a Voter Precinct on JMU Campus

- The issue is not about "voter rights" but "voter privilege". JMU students are already voting in the city at the Spotswood Elementary School precinct.
- Establishing a distinct and separate precinct on JMU campus sets an outstanding precedent, i.e. if you can pay for it the city will do it. Objections to consider:
 - o Could a neighborhood request their own precinct if they agreed to pay for it?
 - Could another institution, VMRC perhaps, request a precinct if they agreed to pay for it?
 - Instead of fostering JMU's intended plan to interface more with the community, this request actually provides more exclusion and separation for the JMU community.
 - We are providing more convenience for JMU students than we provide for our own registered voters.
 - Other registered voters will view this as another accommodation to JMU rather than an action based on what is most appropriate for the city voters.
- The impression has been given that most state colleges\universities have their own polling place on campus exclusively for students, the reality is that only one state-owned college\university does: VPI. Liberty University, which is a private university, also has its own precinct exclusively for students. Two other state universities, UVA and George Mason, have an on-campus precinct but they are for students and local residents, not just students.
- While some registered voters in our precincts have to travel from 1.2-3.0 miles to get to their respective polling place, JMU students from the farthest point on campus have to travel only 0.8 miles. In fact, on-campus students are closer to their current precinct than the majority of city voters are to theirs.
- With a precinct selectively placed on JMU's campus for its students, the impact on an
 election in which a JMU professor or employee is running for local office has the
 potential of wresting the control of City Council from the local registered voters
 to the JMU students. Additionally, a JMU student could win a seat on City
 Council based on JMU votes entirely.

- Based on past voting records, the request would not have merited the Electoral Board's investigation.
 - o In 2014, 173 of 2240 (8%) registered on-campus students voted.
 - o In 2013, 263 of 2250 (12%) registered on-campus students voted.
 - In 2012, 883 of 2320 (38%) registered on-campus students voted in the Presidential Election
- Currently, city precincts are established for a maximum of 5000 registered voters. In 2014, there were 2240 on-campus registered voters at JMU. Removing that many from the polls at Spotswood would necessitate a redistricting of all the polls in the city. Since this will probably need to be repeated after the 2020 census, the question arises as to why it should be done twice in 4 years.
- The impact on local elections from the JMU campus is significant. While past voting records indicate only a yearly average of 330 on-campus students voting, many local elections have been shifted by less than 150 votes.
- Instead of the time and expense of a separate precinct on JMU's campus, busing can be provided for the students to their polling station, Spotswood Elementary School, at no expense to the students.
