BOARDS AND COMMISSIONS CITY MANAGER ASSIGNMENTS

Harrisonburg-Rockingham Regional Sewer Authority Board (HRRSA). City Manager is a designated board member (there are three other citizen appointees). Deputy City Manager is an alternate for any of the four. This Board meets on the first Monday of each month at 3:00 PM at the HRRSA facility in Mt. Crawford.

Harrisonburg-Rockingham Emergency Communications Center City Manager is part of the two-member Administrative Board for the ECC (the Rockingham County Administrator being the other member). City Manager has generally been the Board Chair as the City is the fiscal agent for the ECC. Deputy CM is the alternate when CM is unable to attend meetings. This Board meets quarterly on the fourth Thursday of the month at 9:00 AM at the Public Safety Building.

Harrisonburg-Rockingham Social Services District City Manager is part of the two-member Administrative Board (the Rockingham County Administrator being the other member). The County Administrator has generally been the Board Chair as the County is the fiscal agent for the ECC. Deputy CM is the alternate when CM is unable to attend meetings. This Board meets on the fourth Thursday of the month at 2:00 PM at the Social Services Building.

Middle River Regional Jail Board of Directors The City Manager, Director of Finance and Chief of Police all serve on this Board, which meets quarterly at the Augusta County Government Center in Verona, usually on the second Tuesday of the month at 10 AM.

Shenandoah Juvenile Detention Center Board of Directors. This Center's member localities consist of Harrisonburg, Rockingham, Staunton, Augusta, Waynesboro, Rockbridge and Lexington. The City Manager is the City's board member. The other localities are also represented by their manager/administrator. This board meets quarterly on the first Friday of the month at 11:00 AM at the Detention Center offices, located in Verona.

Community Criminal Justice Board. As the City and County share Courts, Jail, Sheriffs Office and Commonwealth Attorney functions, this is a joint board. The City Manager and a Council representative are on this committee, which is now meeting on a quarterly basis, generally on a Monday at 4:00 PM at the County Administrative offices.

City/School Board Liaison Committee The City representatives include the Mayor, Vice Mayor and City Manager. This group meets monthly, usually on the third Tuesday or Wednesday at 7:30 AM, rotating between the School Admin. offices or the City Manager's office.

City/County/JMU Liaison Committee This group meets quarterly at the JMU Board of Visitors Dining room. The day of the week is not consistent, but the meetings are usually held at 12:00 noon. The City Manager, Mayor and a Council representative are on this committee, along with counterparts from Rockingham County, and the President, Vice President and JMU support staff.

City/County Liaison Committee - This group meets on more of an "as needed" basis and includes the City Manager, Mayor and a Council member. Meetings are generally held at 7:00 or 7:30 AM and rotate between City and County offices.

Metropolitan Planning Organization This group meets monthly, usually at the Rockingham County Administrative Offices, on the third or fourth Thursday of the month at 3:00 PM. The City is represented by three Council members, the City Manager and the Director of Public Transportation.

Deer Population Task Force: The Deer Population Task Force oversees regulations of the taking of deer with archery equipment during the Early Special Archery Season, the Full General Firearms Deer Season and the Late Special Archery Season, as designated by the Virginia Department of Game and Inland Fisheries. The deer-hunting regulations set forth by the Virginia Department of Game and Inland Fisheries include several limitations relating to geographic areas, elevated stands, proximity to structures and streets, and the prohibited use of firearms.

Finance Committee
