The design team would be happy to see food trucks visit the park if desired by the community. We can perhaps designate few areas in the parking lot as potential food truck areas.

6 Concern raised about having children and dogs in close proximity. Suggest locating future dog park at another site.

There was a strong desire for a dog run to be included in the masterplan. It was one of the top most requested facility by the residents and survey respondents. Also, according to the public engagement comments, currently the grassy area next to Kids Castle is frequently used for off-leash dog play.

The team suggests including an enclosed off-leash dog park on the other side of Blacks Run, outside of the 100-year floodplain to avoid any perceived conflict with children's play area.

If the dog park can be accommodated elsewhere in the City, then it need not be duplicated at Purcell Park.

7 Desire for regulatory and wayfinding signage to be included in phase one.

There is a signage allowance in phase one, with exact content to be determined. Signage should be integral part of each phase. We will review the current language in the master plan and if needed we will add supplimental language to the report.

8 Suggestion to turn the hillside into an arboretum with food events.

JMU's Edith J. Carrier Arboretum is less than a mile from Purcell Park, so the design team has reservations about proposing such a duplication of services in the City. Arboretums require much more maintenance and trained horticultural staff than the City might be prepared to support at this time. We think food demonstrations or other culinary events would be very welcomed in Purcell Park. Perhaps if the City is interested in aquiring Funky's Skatepark then some sort of facility at that location can be developed which can support the demonstration kitchen and such other programming. We will include such language in the master plan.

9 Suggestion to include sidewalks and bike paths along Monument Ave.

Neither bike paths nor sidewalks are recommended along Monument Ave in the 2017 City of Harrisonburg Bicycle and Pedestrian Plan. While the design team supports a strong pedestrian and bicycle network, these streetscape improvements will increase traffic on these residential streets. What Purcell Park needs is a stronger presence on South Main street and that is why the master plan proposes that the city work to expand the park in that direction.

10 Consider using solar energy for lighting and other power needs in the park.

A recommendation to study the feasibility of solar lighting can be included in the masterplan.

11 Question raised how the masterplan would be affected without the acquisition of new property.

The addition of a new parcel outside of the floodplain allows for additional amenities such as increased parking, new restrooms/park center building and a dog park. In addition, the acquisition would allow a front door entry off South Main Street and improved public transportation access. Without it such amenities would not be feasible, but other program elements of the masterplan could still be accomodated.

Can Phase I include some of the easy low-cost improvements in that are currently part of Phase II or III?

LSG will revise master plan text to include language that identifies such improvements for City's consideration.
