RE: 2018 VA DCJS Grant Award

<u>Summary:</u> On May 15th, 2018 the Virginia Department of Criminal Justice Services awarded the Harrisonburg Police Department (HPD) a one-time grant fund to purchase equipment and services for creating a professional recruitment video that would be shown on a large screen at career fairs and other police recruitment events

<u>Background:</u> The grant period runs from April 1, 2018 through September 30, 2018 and is a sub-grant award from the DCJS Edward J Byrne Memorial Fund/Justice Assistance Grant. The funds were made available to facilitate Law Enforcement Staff Recruitment and Retention.

<u>Key Issues:</u> HPD plans to work with a local production firm to prepare four short informational videos targeting the type of individuals we want to hire as police officers. These videos will be used in public service announcement, displayed at job fairs and posted on social media platforms. We also plan to engage a local design firm to create a graphics package and mobile booth that will allow a branded HPD presence at job fairs and recruitment events.

### Environmental Impact: non

<u>Fiscal Impact:</u> Grant funding totaling \$11,814.78 will be reimbursed after expenditure: \$4,464.80 for mobile booth display system. \$949.99 for iPad pro and \$549.99 for Sony smart TV. \$5,850.00 for Promotional video production.
