

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HARRISONBURG, VIRGINIA,  
SETTING SOLID WASTE COLLECTION AND MANAGEMENT FEES

WHEREAS, pursuant to Virginia Code Sections 10.1-1411 and 15.2-939, the City of Harrisonburg has adopted a solid waste management plan, and

WHEREAS, pursuant to Virginia Code Section 15.2-928, the City of Harrisonburg is authorized to operate solid waste management facilities and appurtenances for the collection, management, recycling and disposal of solid waste, recyclables, materials, and other refuse of the residents and businesses of the City, to generally regulate the operation of a solid waste management program, and to charge and collect compensation for such services, and

WHEREAS, pursuant to Harrisonburg City Code Section 6-2-39, the monthly rates charged for the collection of refuse by the City from within the City is to be fixed from time to time by the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HARRISONBURG, VIRGINIA:

That the City Council of the City of Harrisonburg, Virginia hereby fixes the following rates for the collection of refuse by the City:

Solid Waste Management Fee

Every house holder, whether owner or tenant, and every business, commercial, institutional, and industrial establishment in the City shall pay an ~~\$44~~\$10.00 a month Solid Waste Management Fee.

Refuse Collection Fee

Residential ~~\$24~~\$22.00/per month. Such monthly fee shall include the following collection services:

5 units per week  
10 units yard debris collected once every two weeks  
5 units bulk collection collected once every two week's Unlimited recycling  
~~(\$11.00 is applied to the Solid Waste Management Fee)~~

Commercial, business, institutional, industrial, or other non-residential monthly charges:

1 Unit/Day or 5 Units/Week ~~\$34~~\$30.00  
2 Units/Day or 10 Units/Week ~~\$54~~\$50.00  
3 Units/Day or 15 Units/Week ~~\$74~~\$70.00  
4 Units/Day or 20 Units/Week ~~\$94~~\$90.00  
5 Units/Day or 25 Units/Week ~~\$114~~\$110.00  
6 Units/Day or 30 Units/Week ~~\$134~~\$130.00  
7 Units/Day or 35 Units/Week ~~\$154~~\$150.00

8 Units/Day or 40 Units/Week \$~~171~~170.00  
9 Units/Day or 45 Units/Week \$~~191~~190.00  
10 Units/Day or 50 Units/Week \$~~211~~210.00  
15 Units/Day or 75 Units/Week \$~~231~~230.00  
20 Units/Day or 100 Units/Week \$~~251~~250.00  
25 Units/Day or 125 Units/Week \$~~271~~270.00  
30 Units/Day or 150 Units/Week \$~~291~~290.00  
35 Units/Day or 175 Units/Week \$~~311~~310.00  
40 Units/Day or 200 Units/Week \$~~331~~330.00  
(~~11.00 is applied to the Solid Waste Management Fee~~)

A "unit" is one container described in Harrisonburg City Code Section 6-2-29 or a bundle of wastepaper or vegetative matter as described in Harrisonburg City Code Sections 6-2-33 and 6-2-34.

For additional units of trash, refuse stickers will be sold at the Treasurer's office for \$1.00 each.
