RE: Resolutions approving issuance by Harrisonburg Redevelopment and Housing Authority of Revenue Bonds for the acquisition, construction, and equipping of an approximately 80-unit multifamily residential rental housing project and an approximately 84-unit age-restricted senior living housing facility (the "Projects") in the City of Harrisonburg, Virginia, on behalf of the Beverly J. Searles Foundation and its Affiliates

**Summary:** HRHA is requesting that Council pass the above referenced resolutions approving two bond issuances. Council approval of HRHA's issuance of the bonds is required by state law. There is no liability incurred by the City as a result of this approval and the issuances of the bonds by HRHA. Council approved identical resolutions for these projects on November 28, 2023, but the projects were delayed. These resolutions expire after one year, so HRHA is asking for updated resolutions.

**Background:** HRHA routinely acts as the issuer of private activity bonds to finance housing projects around Virginia. Fees generated by such bond issuances are used by HRHA to finance some of its work in Harrisonburg. HRHA is acting as the issuer of such bonds for the Projects in the City of Harrisonburg, Virginia, located at 210 and 280 W Mosby Road in Harrisonburg, Virginia, and more particularly described in the resolutions attached to the agenda for this item. Under Virginia law, City Council must approve HRHA's issuance of the bonds prior to the issuance. There is no liability assumed by the City in approving the attached resolution or in the issuance of the bonds.

<u>Key Issues</u>: Approval of two resolutions approving HRHA's issuance of bonds for the two Projects in Harrisonburg, Virginia.
