Staff will give an update regarding this concern, which was brought to TSAC at a previous meeting.

#### 5. Vine St overnight truck restrictions

Staff plan to install signs at the intersection of N. Main St & Vine St and the intersection of Old Furnace Rd & Vine St to re-install the overnight truck restriction for this segment of Vine St.

#### 6. Northeast Neighborhood Intersection safety concerns

Staff have received a concern about crashes, and near-misses, at intersections in the Northeast Neighborhood. The locations with the highest volumes of crashes are Gay St & Hill St, Gay St & Sterling Ave, and Wolfe St & Sterling Ave.

#### 7. Greendale Rd Curve

Staff reviewed the crash reports and will provide information about their findings and suggested measures to improve safety at this location.

#### 8. Smithland Rd Speed Limit

Public Works staff have evaluated the speed limit on the segment of Smithland Road that contains the bridge over I-81. Staff are proposing a reduction in the speed limit to 40 mph.

#### 9. Blue Ridge Dr speeding concerns

Staff will provide the data from the traffic study that was completed, as well as potential measures that could be implemented to address the speeding concerns.

#### 10. Intersection Sight Distance Concerns due to fences

The following locations have been identified as having sight distance concerns due to fences: Neff Ave & Putter Ct intersection, Peach Grove Ave & Lois Ln intersection, and the apartment complex entrance near 873 Port Republic Rd.
