### 3.a. **Election of Mayor**

City manager Banks opened the floor for nominations for Mayor for Harrisonburg City Council.

Council Member Robinson nominated Dany Fleming for Mayor. Council Member Fleming declined nomination.

3.p. Appoint two members of council to serve as liaison to the JMU Liaison Committee

A motion was made by Vice Mayor Fleming, seconded by Council Member Dent, to appoint Council Member Robinson and Vice Mayor Fleming to the James Madison Liaison Committee. The motion carried with a unanimous voice vote.

**3.q.** Appoint three members of council and two staff members and their alternates to the Harrisonburg-Rockingham Metropolitan Planning Commission

A motion was made by Vice Mayor Fleming, seconded by Council Member Dent, to appoint Council Member Dent, Vice Mayor Fleming, Council Member Alsaadun, City Manager Banks, and Amy Snider, deputy city manager as his alternate, Gerald Gatobu, director of Harrisonburg Department of Public Transportation and Cheryl Spain as his alternate, to the Harrisonburg Rockingham Metropolitan Planning Commission. The motion carried with a unanimous voice vote.

**3.r.** Appoint one member of council to the Harrisonburg-Rockingham Chamber of Commerce Board

A motion was made by Vice Mayor Fleming, seconded by Council Member Dent, to appoint Vice Mayor Fleming to the Harrisonburg Rockingham Chamber of Commerce Board. The motion carried with a unanimous voice vote.

**3.s.** Appoint one member of council to serve on the Harrisonburg Downtown Renaissance Board of Directors
