Why are you interested in serving on a board or commission?

My name is Amanda Morris, and I have dedicated my career to supporting vulnerable individuals and families in Harrisonburg through direct service, case management, policy advocacy, and community-based resource coordination. I currently work as a Care Coach with Humana Healthy Horizons and have previous experience serving as the Director of Case Management at Our Community Place, where I supported adults experiencing homelessness, housing instability, chronic health issues, and complex systemic barriers. My work is deeply rooted in social justice, trauma-informed care, and building pathways for people who are often overlooked by traditional systems. Much of my experience involves collaborating with HRHA on behalf of clients—navigating vouchers, addressing barriers to housing, and advocating for fair, equitable access to resources. These experiences have given me not only a strong understanding of housing programs but also a grounded awareness of the real challenges residents face when navigating local housing systems.

What other interests or concerns do you have regarding the community?

I am especially concerned about the challenges that affect a person's ability to stay stably housed—such as access to transportation, behavioral health support, food stability, and financial barriers. These issues often determine whether someone can maintain their housing, so they connect directly to HRHA's mission. I'm also interested in strengthening collaboration between HRHA and other local agencies. Many residents rely on multiple services at once, and clearer communication and coordination can make the housing process smoother and more accessible. Finally, I care deeply about equity. Harrisonburg is diverse, and I want to help ensure HRHA programs remain inclusive and responsive to the needs of low-income families, older adults, people with disabilities, and those experiencing homelessness. Overall, my interest is in helping HRHA remove barriers, improve access, and support long-term stability for the residents we serve.

What relevant experience or education do you have to this board or commission?

have several years of direct experience supporting individuals and families in Harrisonburg with housing, benefits, and community resources. I previously served as the Director of Case Management at Our Community Place, working closely with clients navigating HRHA vouchers, homelessness, and housing barriers. I now work as a Care Coach with Humana Healthy Horizons, providing care coordination and stability planning for members with complex needs. I hold a Bachelor's degree in Human Services from Southern New Hampshire University and am completing MSW coursework at the University of Central Florida. I also hold certifications in SOAR, Brain Injury Fundamentals, Mental Health First Aid, and First Aid/CPR/AED. My education and frontline work give me a strong understanding of housing policy, local resources, and the challenges residents face—experience that I believe would be valuable to the HRHA Board.

I am actively involved in the Harrisonburg community through housing advocacy, disability support, and cross-agency collaboration. I previously served as Director of Case Management at Our Community Place and currently serve the community as a Care Coach with Humana Healthy Horizons, supporting older adults and individuals with disabilities. I have also organized community food-box drives and partnered with HRHA, Mercy House, VPAS, and other agencies to strengthen support systems and promote housing stability
