1.) THE PURPOSE OF THIS SURVEY IS TO CONVEY 41 SQ. FT. OF NORWOOD STREET TO NEIGHBORHOOD RENAISSANCE, L.L.C. IN ORDER TO MEET THE BUILDING'S 30' FRONT SETBACK AND TO CONVEY A PUBLIC STREET EASEMENT TO THE CITY OF HARRISONBURG WHERE NORWOOD STREET PASSES THROUGH THE NEIGHBORHOOD RENAISSANCE LOTS.
