Please tell us about yourself and why you want to serve.

Why are you interested in serving on a board or commission?

I'm interested in serving on Planning Commission because Harrisonburg faces a severe housing shortage. I'm an attorney living in the Northwest Neighborhood and working downtown, often with clients in economic distress and difficulty with transportation/housing options.

What other interests or concerns do you have regarding the community?

I am strongly motivated by my interest in making our community a more walkable, bikable, and affordable place. After we bought our house last year, our current landlord sought to raise our rent by about \$500 per month. Many friends experienced similar increases. The cost of new vehicles continues to rise substantially. In short, we need more housing. The location and kind of housing we create has a strong impact on affordability, as does including mixed-use development alongside housing. We must encourage thoughtful incremental residential growth in most areas of the city, and substantial residential growth in key areas like downtown. We must do so with special regard for historically marginalized communities, particularly North Downtown/Northeast Neighborhood.

What relevant experience or education do you have to this board or commission?

I am an attorney for the Ritchie Law Firm, focusing on personal injury, social security disability, and workers compensation. My clients, necessarily, are people hurt by car-centric development, exacerbated by overly restrictive zoning codes. When low-income clients are hit, they lose time from work, their transportation is in danger, and it can set off a vicious cycle often leading to eviction. I am a graduate of Washington and Lee University School of Law, having taken courses in administrative law, environmental law, and land use/zoning. As an attorney and local housing advocate, I have a grounded understanding of zoning and its legal basis.

Please list any past or present community involvement e.g. City Council, Boards and Commissions, Citizen Academy, etc. in Harrisonburg or elsewhere:

I have served on Harrisonburg Redevelopment Housing Authority since 2023. I completed Citizens' Academy in 2022. I am serve as chair of Climate Action Alliance of the Valley (CAAV), and help to coordinate climate outreach. I have attended or observed several meetings of City Council, Planning Commission, Bicycle and Pedestrian Subcommittee, and EPSAC in the past 3 years for CAAV. I coordinate Livable Harrisonburg, a group of residents focused on promoting walkability, bikeability, and affordable housing in Harrisonburg.
