

Who We Are

HRMPO is the regional transportation planning body for the City of Harrisonburg, the urbanized portion of Rockingham County, and the Towns of Bridgewater, Dayton, and Mt. Crawford.



Who We Are



- Our Policy Board is comprised of elected officials and administrators from our member jurisdictions, as well as transportation agency representatives.
- Our Technical Advisory Committee (TAC) is comprised of City, County,
 Town, and agency staff with expertise in planning, engineering and related fields.
- The Central Shenandoah Planning District Commission staffs HRMPO.

Long Range Transportation Plan (LRTP)

The LRTP creates an effective framework for mobility and development with a set of priority transportation investments to address the area's current and long-term needs. The Plan is updated every five years.

Public Input in the LRTP Process




Public Input



- In Phase One, we heard from 638 community members who shared their vision for the future of transportation in the region.
- In Phase Two, we heard from 685 community members who gave their feedback on the list of proposed transportation projects.
- In Phase Three, we heard feedback on the draft LRTP document from 19 people providing over 55 comments.


LRTP Fiscally-Constrained Project List


- 47 total projects in the MPO
 - 30 Funded Projects
 - In the Six-Year Improvement Plan
 - 17 New Projects
 - Projected funding
- Over \$400 million in committed and projected funding



Harrisonburg Newly-Committed Projects


- Mt. Clinton Pike Corridor Safety
 - Install sidewalk on north side from Acorn Dr. to N. Main St. Install pedestrian crossing for Northend Greenway at railroad crossing near VA-42 (Virginia Ave.). Install roundabout at Acorn Dr.
- Old Furnace Road Sidewalks
 - Construct sidewalk to fill gaps and add pedestrian infrastructure at intersections to create continuous pedestrian route between Summit St. and Oriole Ln

 - 8 in Harrisonburg
- Virginia Ave (VA 42) Safety and Speed Mitigation Measures
- Vine St. & Old Furnace Rd. Roundabout Evaluation
