The certificate of insurance shall name the City as an additional insured, in the amount not less than one million dollars (\$1,000,000.00).

WITNESSETH:

- 1. <u>Encroachment Area</u>. City hereby grants permission to <u>Black Sheep Coffee</u>, <u>LLC</u> to encroach into the public right-of-way adjacent to 80 E Market St, Harrisonburg, VA 22801 for the purposes of installing <u>planters</u> of a substantially similar design and at a substantially similar location as shown on <u>Exhibit A</u>, attached.
- 2. <u>Liability Insurance</u>. <u>Black Sheep Coffee, LLC</u> shall acquire and maintain in effect a commercial general liability insurance policy which serves to insure the City and its officers, employees and agents against liability resulting from the placement, existence, maintenance, inspection and removal of the planters. Such certificate of insurance must be filed with the City Clerk prior to the issuance of any required building permits for the encroachment permitted.
- 3. <u>Indemnification</u>. <u>Black Sheep Coffee, LLC</u>, its owner, officers, agents, assigns, and successors in interest of the planters installed on public property hereby indemnify and hold harmless the City of Harrisonburg and its officers, agents, and employees from any and all claims, legal actions, and judgments advanced against the City and for any expense the City may incur in this regard, arising out of the encroachment permitted.
- 4. <u>Discontinuance</u>. <u>Black Sheep Coffee, LLC</u> understands that this Agreement is made pursuant to Section 15.2-2010 of the Code of Virginia, which allows City Council to discontinue this license at any time for good cause and at the expense of the then owner of the encroaching projection.
