Special Use Permit – 201 South Avenue (To allow restaurants in M-1)

A request from Gerardo Pandolfi, Ana C. Parietti, Camila Parietti Pandolfi, and Belen Martinez for a special use permit per Section 10-3-97 (1) to allow restaurants in the M-1, General Industrial District. A request from DCI Partners LLC for a special use permit per Section 10-1-91 (9) to allow reduction in required side and/or rear yard setbacks in the B-2, General Business District. The +/- 5.91-acre property is addressed as 810 Port Republic Road and is identified as tax map parcel 92-A-1.

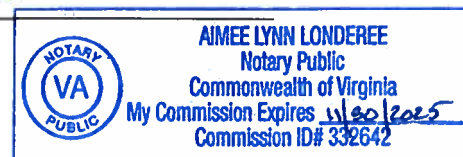
