I hope this letter finds you well. I am writing to request your consideration for an amendment to the existing ordinance that affects the ability of Cat's Cradle of the Shenandoah Valley, Inc., a local nonprofit cat rescue, to adopt out cats on-site at our current location at 122 S Main Street in Harrisonburg.

At present, we are required to drive our adopted rescue cats to the Harrisonburg PetSmart for final adoptions, as we are unable to complete this process directly at our facility. This creates significant logistical challenges for our organization, especially when it comes to coordinating volunteers to transport the cats. Since we cannot close our business during the workday, we are often forced to rely on volunteers to assist us in this transportation. Additionally, the requirement to transport the animals to a separate location impacts our ability to provide timely adoptions and meet the needs of prospective adopters.

In many cases, when a potential adopter falls in love with a cat, they are eager to take the cat home that same day. However, under the current ordinance, this is not possible. The added steps involved in transporting the cat to PetSmart can cause delays and sometimes discourage potential adopters from completing the process. As you can imagine, time is often of the essence when it comes to animal adoptions, and this ordinance significantly impedes our ability to facilitate a smooth and efficient adoption experience for both the cat and the adopter.

We respectfully ask that the City of Harrisonburg consider amending the ordinance to allow Cat's Cradle of the Shenandoah Valley, Inc. to complete adoptions directly at our facility. This change would not only streamline the adoption process but also help us reduce unnecessary delays, allowing us to place more cats in loving homes where they belong and keep cats out of your local municipal shelter.

We are happy to discuss this request further and provide any additional information or clarification you may need. Thank you for your time and consideration of this important matter. We look forward to your support in making this change, which will allow us to better serve our community and the animals in our care.

Pet Adoption: The transfer of ownership of a dog or cat, or any other companion animal as defined in the Virginia State Code, from a releasing agency to an individual. Such transfer of ownership does not include the purchase, sale, transfer, exchange or bartering of companion animals for compensation or profit.

Pet shop: Retail establishment where companion animals are bought, sold, exchanged, or offered for sale or exchange to the general public.

Hello Sherri,

Since I edited the draft language for the ordinance amendment, I would like to make sure that you agree with the draft. The proposed language is to add the definitions for "pet adoption" and "pet shop". "Pet adoption" is added to the uses permitted by right in B-1 to allow the not-for-profit exchange of companion animals in the B-1 district.

To ensure that there is no change or confusion about what is allowed in B-2, the by-right uses will include both pet adoption and pet shop.
