RE: Personal Property Tax Exemption for Virginia Clean Cities; Real Estate and Personal Property Tax Exemption for Strength in Peers Inc Tax Map 041 C 41-AT; and Personal Property Exemption for Village to Village Inc/Hope4Villages LLC

Dear Mayor Reed:

In accordance with the guidelines of City Code §4-2-17 Exemptions for designated real property and designated personal property owned by certain nonprofit organizations; the committee has reviewed all the Applications for Tax Exemptions and all the supporting documentation (IRS exemption, tax returns, articles of incorporation, and bylaws etc.) for Virginia Clean Cities; Strength in Peers Inc, and Village to Village Inc./Hope4Villages LLC. Each nonprofit organization tax revenue exemption and committee recommendation is detailed below:

-Virginia Clean Cities personal property tax exemption at the FY 26 vehicle tax rate of \$3.45 per \$100 of assessed value would generate \$2,022.56 in FY 26. The committee recommends that the City Council approve the request for exemption.

-Strength in Peers Inc. real estate tax exemption at the FY 26 tax rate of \$1.01 per \$100 of assessed value would generate \$6,331.68 of revenue in FY 26. The personal property tax exemption at the FY 26 vehicle tax rate of \$3.45 per \$100 of assessed value would generate \$1,055.63 of revenue in FY 26. The committee recommends that City Council not approve the request for real estate exemption because City Code Section 4-2-17 (a)(3) states the property for which the exemption is requested shall not be occupied or used by any person as a dwelling or for other personal use. The committee recommends that City Council approve the request for personal property exemption.

-Village to Village Inc personal property tax exemption at the FY 26 tax rate of \$2.12 per \$100 of assessed value would generate \$176.70 of revenue in FY 26 and the vehicle personal property tax


at the FY 26 rate of \$3.45 per \$100 of assessed value would generate \$175.81 of revenue in FY 26. Hope4Villages LLC, the single member LLC of Village to Village Inc, personal property tax exemption at the FY 26 rate of \$2.12 per \$100 of assessed value would generate \$116.62 of revenue in FY 26. The committee recommends that City Council approve the request for exemption.


