Amending and re-enacting the Harrisonburg City Code Section 7-4-1(a)(1)(a), 7-4-1(a)(1)(b), 7-4-1(a)(2)(a), 7-4-1(a)(2)(b) to <u>increase</u> city and rural water rates by \$.22 per one thousand (1000) gallons as follows:
