I, Pamela Ulmer, city clerk, certify that the Harrisonburg City Council will be addressed on Tuesday, February 24, 2026 7:00 p.m., or as soon as the agenda permits, to consider the following:

Special Use Permit – 380 Sunrise Avenue (To allow reduction in required side yard setback in R-8)

A request from Jason Burch for a special use permit per Zoning Ordinance Section 10-3-59.4 (11) to allow a reduction in required side yard setbacks in the R-8, Small Lot Residential District. The +/- 13,300-square foot property is addressed as 380 Sunrise Avenue and is identified as tax map parcel number 23-A-1 and 2. Note that a separate request by AM Yoder & Co to amend Zoning Ordinance Section 10-3-59.4 (11) was presented to Planning Commission on December 10, 2025 and is scheduled for public hearing at City Council on January 13, 2025.

Special Use Permit – 660 Walnut Lane (To allow multiple-family dwellings of up to 12 units per building)

A request from Craig D. and Sue W. Smith for a special use permit per Zoning Ordinance Section 10-3-48.4 (6) to allow multiple-family dwellings of up to twelve (12) units per building under conditions set forth in subsection 10-3-48.6 (e). The +/- 16,400-square foot property is addressed as 660 Walnut Lane and is identified as tax map parcel 25-L-8-A.

Rezoning – 2600 & 2580 South Main Street (M-1 to R-3C)

A request from Todd B. Stone to rezone a +/- 3.0-acre portion of a +/- 13.14-acre parcel zoned M-1, General Industrial District to R-3C, Medium Density Residential District Conditional. The property is addressed as 2600 and 2580 South Main Street and is identified as tax map parcel 2-B-5.

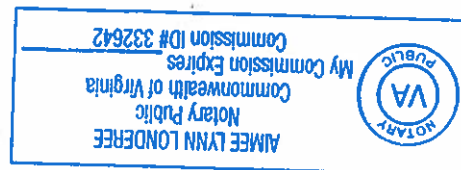
