RE: Public Access Permit Program

**Summary:** The Public Works Department is requesting that City Council consider adopting the updates to the Public Access Permit program as presented at the September 24, 2019 Council meeting.

**Background:** The Public Works Department presented to City Council on September 24, 2019 and shared the updates to the Public Access Permit program. However, City Council was not asked to adopt those changes and this item is to request that City Council consider adoption. Below is the explanation of the updates that discussed at the September 24, 2019 Council meeting.

The Public Works Department currently issues Public Access Permits (PAP) to anyone performing work within the City's right of way. The PAP grants the permittee permission to work within the right of way and if necessary, install items within the right of way as well. Permit requests include items such as; private entrances, commercial entrances, underground and above ground telecommunication lines, gas lines, etc. Public Works issued 121 permits in 2017, 232 permits in 2018, and 117 permits so far in 2019.

The current permit program includes a one-page application that is reviewed and approved by Public Works prior to the work being performed. It does not include any type of fee structure or bonding requirements, nor does it include permit durations and expiration dates. The updated program includes these items as well as other changes that are meant to improve the permitting process.

Below is a summarized list of changes:

- Includes a non-refundable \$100 application fee for any submitted PAP. This fee is consistent with the VDOT Land Use Permit program.
- Additive fees for permitted activities that vary per activity. These fees offset the inspection costs associated with these types of activities. These fees are consistent with the VDOT Land Use Permit program.
- Surety requirements based on the value of the work performed in the right of way.
- Permit expiration dates and reinstatement fees if permit extensions are required.
- Enhanced City department coordination with the utilization of the LAMA permitting system.
