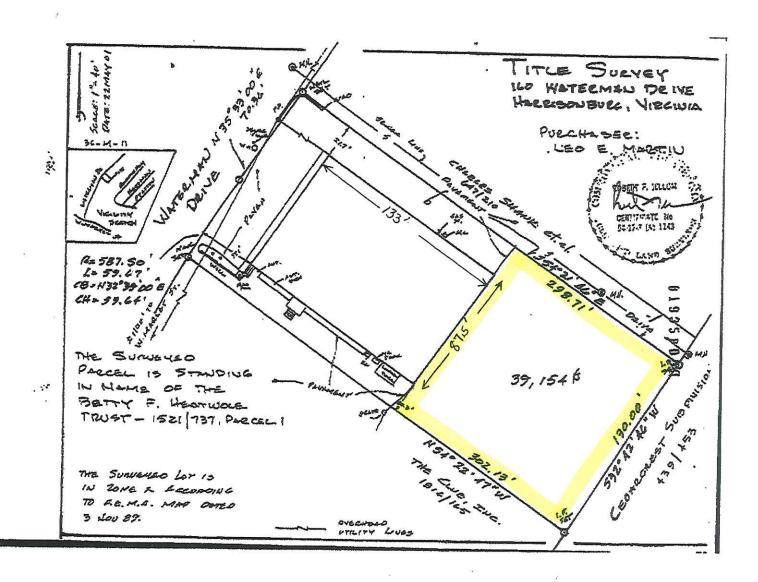

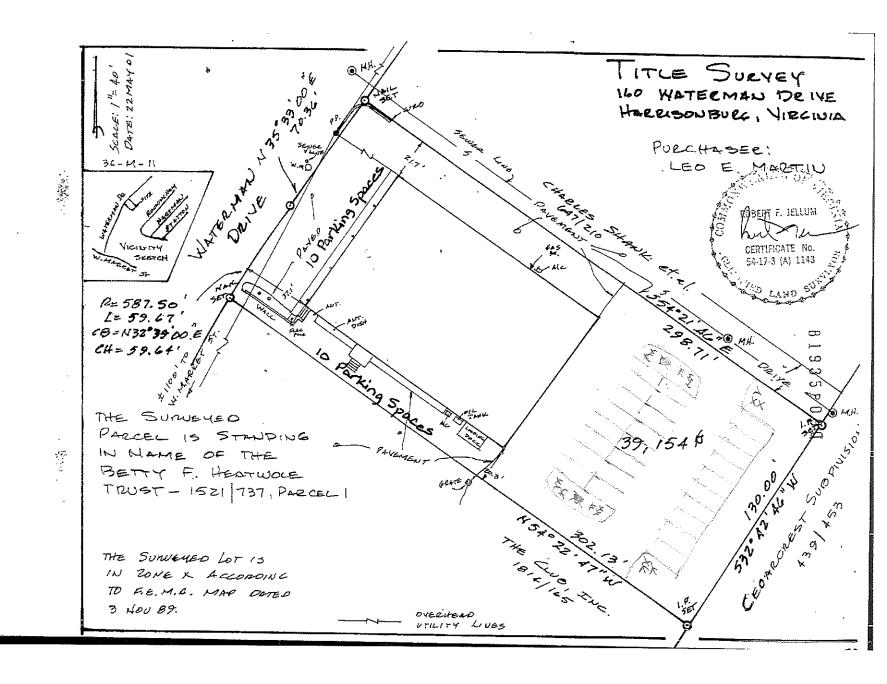

WITNESSETH:

DOLLARS (\$10.00), cash in hand paid by the Grantee to the Grantors, and for other good, valuable and sufficient consideration passing between the parties hereto, at and before the execution and delivery of this deed, the receipt of all of which is hereby acknowledged, they, the said Grantors have bargained and sold and do hereby grant and convey with GENERAL WARRANTY AND ENGLISH COVENANTS OF TITLE, unto the said Betty F.
