Nate Riddle, executive director, Open Doors, presented an update on the past year of the Navigation Center. He reviewed the following:

**7.c.** Consideration approval of a Memorandum of Understanding between National League of Cities and Harrisonburg

Brian Shull, director of Economic Development, presented a request related to the National League of Cities (NLC) Southern Cities Economic Initiative (SCEI). He thanked Council for their continued support for small businesses in the City and reviewed some of the programs already in place. He stated this Memorandum of Understanding will help to further the Harrisonburg Entrepreneurship Development Initiative (HEDI) program with a \$52,500 grant.

Vice Mayor Fleming stated throughout the grant process Harrisonburg continued to be one of the top contenders because of the great work our Economic Development staff has done for entrepreneurs in the city.

**8. Other Matters**

**8.a. Comments from the public, limited to five minutes, on matters not on the regular agenda. (Name and address are required)**

Panayotis "Poti" Giannakouros, spoke on the recent People's Day event; civic conversations; and city fees for violations of city ordinances;

**8.b. City Council and Staff**

Council Member Alsaadun spoke on the Dr. Martin Luther King, Jr 25th Annual Leadership Award he received from the Fellowship Church of the Brethren; and his attendance in Richmond with leaders from Church World Services advocating for refugees and immigrants and the delegates were very welcoming.

Council Member Dent spoke on her attendance at a vigil on Court Square and recent conference attendance. She spoke on bills related to data centers and campaign reform;

Council Member Robinson spoke on her recent participation in the Chesapeake Watershed Forum and stated there are many activities throughout the city this month celebrating Black History Month.

Vice Mayor Fleming recognized the JMU students in attendance; he spoke on his attendance to the Virginia Municipal Leagues Legislative Day conference and some of the bills that may undermine local authority if passed; the additional flights from Shenandoah Valley Regional Airport; recent meeting with area builders and Community Development on ways to streamline building processes; upcoming trip to Birmingham, Alabama for the SCEI through NLC with staff from the Economic Development department;

Mayor Reed spoke on her attendance to some of the Martin Luther King, Jr. Day events at JMU; thanked the JMU students for their attendance; spoke on fear and racism in the community and the country;

Council Member Robinson spoke on the fear and hate that exists in this world and asked that everyone grants grace to those that are living in fear.

Further conversation took place regarding the racism, hate and fear in this country.

Chris Brown, city attorney, stated on April 21, 2026, there will be a special election related to an amendment to the Virginia Constitution on Congressional redistricting. He stated this is causing some challenges for three of our polling locations due to school operations, however, alternate spaces have been found. He stated an amendment to the City Code will need to be approved by Council at the next City Council meeting.

## **HRHA Reconfirmation**

Chris Brown, city attorney, asked council to confirm and ratify the appointment previously made to the HRHA of Anthony Hayes, who at the time of appointment did not live in the city, which disqualified him to serve on board; however, he has since moved into the city and is now eligible.

**A motion was made by Vice Mayor Fleming, seconded by Council Member Robinson to confirm and ratify the appointment. The motion carried with a unanimous voice vote.**

**9. Boards and Commissions**

**9.a. Community Services Board**

A motion was made by Council Member Robinson, seconded by Council Member Dent, to reappoint William Holland to the Community Services Board, to a first full term to expire on June 30, 2028. The motion carried with a unanimous voice vote.

**9.b. Environmental Performance Standards Advisory Committee (EPSAC)**

A motion was made by Council Member Dent, seconded by Council Member Robinson to appoint Admassu Yonathan, Kathleen Holm and Rebecca Schrupp, to the Environmental Performance Standards Advisory Committee (EPSAC) to full terms to expire on 02/10/2029. The motion carried with a unanimous voice vote.

**9.c. Harrisonburg Transportation Safety and Advisory Commission (TSAC)**

A motion was made by Council Member Robinson, seconded by Council Member Dent to reappoint Kyle Lawrence to a third term to expire on December 31, 2028, and appoint Michael Van Poots to a full term to expire on February 10, 2029, to the Transportation and Safety Committee (TSAC). The motion carried with a unanimous voice vote.
