January 18, 2018	<b>Training Session</b> for CDBG Applicants – <b>2:00pm</b>
February 15, 2018	<b>Grant Application Deadline</b> – receipt by <b>NOON</b>
March 1, 2018	<b>Selection Committee Meeting, Consideration of Proposals, &amp; Development of Action Plan</b>
March 27, 2018	<b>Council Meeting/Public Hearing #2</b> (Present Budget, 2018 Action Plan, & open 30 day Public Comment Period – <b>7:00PM</b> )
April 30, 2018	<b>All public comments must be received by 9:00 AM on April 22, 2018 to be considered.</b>
May 8, 2018	<b>Council Meeting/Council Final Approval of 2018 CDBG Budget/Action Plan</b> (Council to consider approval of budget/Annual Action Plan)*
May 15, 2018	<b>Annual Action Plan due to HUD</b>
June 2018	<b>HUD Approval of 2018 CDBG Action Plan</b>
