

## PUBLIC HEARING NOTICE

## CITY OF HARRISONBURG SUBSTANTIAL AMENDMENT TO 2020 ACTION PLAN COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

**PUBLIC HEARING** - The City of Harrisonburg will hold a public hearing on Tuesday, April 12, 2022 at 7:00 p.m. in the City Council Chambers, 409 South Main Street, in order to receive citizen input regarding an amendment to the 2020 Action Plan for the Community Development Block Grant (CDBG) Program. This Action Plan serves as the City's guide for addressing overall community development and housing needs that will utilize the City's annual entitlement of CDBG funding available from HUD to meet those needs. The amendment to be considered at this Public Hearing is as follows:

• \$90,000 of CDBG funding that was designated to the 2020 Administration project will be moved to the 2019 Parks and Recreation Park Accessibility Improvement Project.

Following the Public Hearing, there will be a 30-day Public Comment Period. All citizens and organizations are invited to attend the public hearing to comment orally or in writing on the Annual Action Plan Amendment. Special assistance is available for disabled persons addressing City Council. Efforts will be made to provide adaptations or accommodations based on individual needs of qualified individuals with disabilities, provided that notification at least five (5) business days prior to the date of the meeting has been received by the City Clerk's Office, 409 S. Main Street, 3<sup>rd</sup> Floor at 540-432-7701. Additionally, translation services may be offered upon request and availability. Written comments may be mailed to Kristin McCombe, CDBG Coordinator, Office of the City Manager, 409 South Main Street, Harrisonburg, VA 22801. Comments may also be submitted by calling (540) 432-8926 or emailing kristinm@harrisonburgva.gov.
