RE: Public Hearing for CDBG 2017-2021 Consolidated Plan and 2017 Action Plan

Summary:

The City of Harrisonburg has prepared its Five Year Consolidated Plan for the period of FY 2017-2021, and Annual Action Plan for HUD FY 2017. The City will apply for FY 2017 Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD). This is the second of two Public Hearings for these documents.

Background:

This process is required every five years for CDBG compliance.

Key Issues:

The purpose of the Public Hearing is to once again solicit citizen participation in the process. Citizen participation and comments on the Consolidated Plan, and Annual Action Plan will assist the City in the finalization of these required documents. The Consolidated Plan serves as the planning document for addressing overall community development and housing needs that will utilize the estimated \$450,000 annual entitlement of CDBG funding available to the City to meet those needs. Projects selected to receive funding will be included in the annual Action Plan. As an entitlement community, the City of Harrisonburg, VA receives funding through the Community Development Block Grant Program (CDBG).

The CDBG selection Committee met on March 6, 2017. The attached document that summarizes funding recommendations for the 2017 Action Plan. These numbers are based on an estimated funding allocation of \$450,000. Additionally, staff has decided to roll \$110,000 in previously unspent CDBG funding (primarily from the Administration fund) into the "pot" this year. This brings the estimated amount of CDBG funding to be allocated to a total of \$560,000. We have not yet heard word from HUD regarding the City's allocation amount for the 2017-2018 year. Therefore, contingency plans are in place. The selection Committee is recommending that The Suitcase Clinic, The Arc, Pleasant View, and the Westover Pool projects will all receive more or less funding once we receive final word of the allocation amounts from HUD.
