

NOTICE OF PUBLIC HEARING

ON AN ORDINANCE AMENDMENT INCREASING THE WATER RATES IN THE CITY OF HARRISONBURG

The Harrisonburg City Council will hold a public hearing on June 12, 2018 at 7:00 p.m., or as soon as the agenda permits, in the City Council Chambers located at 409 South Main Street, Harrisonburg, Virginia, to solicit public comments concerning the following:

Amending and re-enacting the Harrisonburg City Code Section 7-4-1(1)(a) and 7-4-1(1)(b) to **increase** city water rates charged by the city as follows:

Gallons used	7-4-1(1)(a) City water per 1000 gallons	7-4-1(1)(b) Rural Water per 1000 gallons
0-2500	\$0.19	\$0.30
2500-25,000	\$0.19	\$0.30
25,000-250,000	\$0.19	\$0.30
250,000 plus	\$0.25	\$0.29

Amending and re-enacting the Harrisonburg City Code Section 7-4-1(1)(d) to increase the minimum water charges by meter as follows:

Meter Size (inches)	City Minimum (per month)	Rural Minimum (per month)
5/8" / 3/4"	\$0.57	\$.90
1	\$9.20	\$14.93
1½	\$18.40	\$29.85
2	(\$21.33)	(\$64.64)
3	\$6.78	(\$33.85)
4	(\$56.30)	(\$181.05)
6	\$90.11	\$27.63
8	\$183.05	\$101.46
10	\$1,262.65	\$1,819.76

Amending and re-enacting the Harrisonburg City Code Section 7-4-1(2)(a) city sewer rate charges will increase by \$.09 per one thousand (1000) gallons; Section 7-4-1(2)(b) rural sewer authority rates will increase by \$.09 per one thousand (1000) gallons;

Amending and re-enacting the Harrisonburg City Code Section 7-4-1(2)(d) to increase the minimum sewer charges by meter as follows:

Meter Size (inches)	City Minimum (per month)	Rural Minimum (per month)
5/8" / 3/4"	\$0.27	\$0.27
1	\$5.80	\$5.80
1½	\$11.60	\$11.60
2	\$18.56	\$18.56
3	\$41.22	\$41.22

6	\$116.00	\$116.00
8	\$185.60	\$185.60
10	\$886.95	\$886.95

All persons interested will have an opportunity to express their views at this public hearing.

Legal authority for the enactment of the above described increases is found in Section 15.2-2119 of the Code of Virginia.

Any person requiring auxiliary aids, including signers, in connection with this public hearing shall notify the City Manager at least five (5) days prior to the time of the hearing.
