THIS DEED, made October 5, 2014, between **Cathy W. HARRISON** and **George Calvin WILLIAMS, EXECUTORS** of the **Catherine L. B. WILLIAMS ESTATE**, grantors, and **Miguel HERNANDEZ AGUIRRE** and **Maria PEREZ REBOLLAR**, husband and wife, grantees, witnesses:

The grantors grant and convey, with special warranty, to Miguel Hernandez Aguirre and Maria Perez Rebolgar, husband and wife, grantees, as tenants by the entirety with the right of survivorship as at common law, all that parcel of land and the rights and improvements belonging to it located in the northeastern section of the City of Harrisonburg, Virginia, fronting 59 feet on the south side of East Johnson Street and running back between parallel lines a distance of 160 feet to an alley in the rear, and designated as **LOT TWENTY THREE (23)** on a plat of the **ZIRKLE ADDITION** to the City of Harrisonburg that is recorded in the Rockingham County Circuit Court Clerk's Office in Hustings Court Book No. 1.

Jerry Williams and Catherine B. Williams acquired this lot as tenants by the entirety from Norma W. Dixon Smith and Robert Lee Smith by deed dated April 18, 1957 and recorded in Deed Book 260, at page 304.

Jerry Williams died on June 17, 2007, vesting title in Catherine B. Williams, who died testate on January 4, 2011. Her will, recorded in the Rockingham County Circuit Court Clerk's Office in Will File # 14-0288, granted her executors the power to convey real estate. The grantors have qualified as executors of her estate.
