2. Crash Data Review

Staff will provide an overview of crashes that have occurred in the city involving people biking or walking. 3. Potential 2023 Transportation Alternatives Program (TAP) grant applications

Funding is available through VDOT's Transportation Alternatives Program every other year, with applications being accepted in 2023. A variety of projects are eligible, and the City has historically applied for projects such as new sidewalks or paths. Staff will provide information about possible projects. 4. Potential 2023 Revenue Sharing grant application

Funding is available through VDOT's Revenue Sharing program every other year, with applications being accepted in 2023. A wide range of transportation projects are eligible. Staff have identified improvements at the intersection of E. Market Street and Sterling Street/Reservoir Street as a potential project. 5. Americans with Disabilities Act (ADA) Self-Evaluation of Public Right of Way

This summer Public Works staff will be completing a self-evaluation of existing pedestrian infrastructure in the City right of way to identify barriers and other hindrances to accessibility. This is a required effort by the Americans with Disabilities Act (ADA) as part of creation of the City's ADA Transition Plan. Staff will provide an overview of what data will be collected.
