Good Morning!

Attached, please find the application for alley closing along with a check in the amount of \$50.00 for the review fee. I am also attaching a copy of the land survey done on July 8, 2019 by Mr. Clint Harmon of Ingram-Hagen Architects, Engineers, and Surveyors located in Verona, Virgina.

I am requesting this closure so that this roughly 2700 square feet can be added to my backyard for the quiet enjoyment by my family. (Two allies; one located at the front and one at the rear of our back yard.) We have lived here since April 1991, and have maintained the space of this alley for more than thirty years. We have graded the alley to be passable after every major rain or snow storm where soil was washed a way leaving massive gullies. We continue to provide this care today, incurring heavy costs to repair and refill the area. The City of Harrisonburg has not maintained the space, and, to my knowledge, has never been to this site to view the damage done by heavy rain and winter storms, nor have we ever witnessed use by the City of Harrisonburg.
