RE: Amendment to allow the keeping of chickens on school property to increase number of chickens permitted

**Summary:** The proposed amendment to Section 15-2-24, Fowl, chickens and other domestic birds, would allow schools to keep chickens on school property, provided the property otherwise meets the conditions for a chicken permit. The proposed amendment also increases the number of chickens allowed with a permit from four (4) to six (6).

Additionally, the amendment clarifies that chickens kept in violation of the ordinance may be impounded and confiscated by the animal control officers, and clarifies the requirements for chicken pens.

**Background:** The proposed amendment to allow schools to keep chickens on school property comes at the request of Amy Sabarre, Director of STEM Education for Harrisonburg City Public Schools. Attached is a detailed proposal written by seventh grade students at Skyline Middle School explaining their reasons for requesting this ordinance amendment.

The proposed amendment increasing the number of permitted chickens from four (4) to six (6) addresses a reoccurring complaint that chicks are often only sold in sets of six.

The proposed amendment also adds language to ensure animal control officers can enforce the chicken permits by impounding or confiscating chickens kept illegally, and provides clearer guidance on acceptable chicken pens.

**Key Issues:** There may be concerns from the local poultry industry, particularly regarding the unintentional spread of diseases.
