This is a request for a special use permit for short-term rental for 341 S. Willow St. Harrisonburg, Virginia 22801 with tax map number 24 D 30, land area of 0.27 acres, and zoning classification of R-1.

The short-term rental will be operated by the property owners, Richard Scott Asbell, III and Jacqueline Mae Asbell. The location of the short-term rental is the primary residence of the operators and the operators will be present during the lodging period. Two bedrooms will be provided for accommodation for up to five guests.
