HGS, LLC is pleased to submit this unsolicited proposal (the "Proposal") for consideration of a full-delivery restoration of (portions of) Blacks Run, in conformance with the City of Harrisonburg's *Procedures Regarding Requests Made Pursuant to the Public-Private Education Facilities and Infrastructure Act of 2002* (Code Ann. §§ 56-575.1 to -575.16), adopted by Harrisonburg City Council on October 26, 2004. HGS, LLC is a wholly-owned subsidiary of Resource Environmental Solutions, LLC (together with all its subsidiaries and affiliates, "RES").¹ Our proposal includes all design, construction, maintenance, and monitoring inherent to this restoration, as well as the documentation and coordination related to generating nutrient and sediment load reductions for the City's compliance with Chesapeake Bay (Bay) Total Maximum Daily Load (TMDL) requirements. This work is referred to herein as the "Project."



RES is a national, fully-scaled operating company providing ecological restoration and water resource solutions. Our goal is to maximize value for our clients by looking for practical, timely, and cost-effective solutions that draw on our depth of expertise and experience across the country.

## Key Differentiators of RES
