





# Question 4 Response – Non-profits

- •Nonprofits and museums they have been excluded from the small business grant program and need assistance similar to what businesses have been receiving. This is more than getting PPE, it's getting operating funds.
- •Assistance with PPE and facility modifications for agencies serving the community.



## Question 4 Response-Childcare

- Working parents that are now LMI need help with daycare/child care and supervision during learning hours due to virtual learning as well as while they are working.
- •I would add to the childcare category, childcare for all ages (including infants and toddlers), not exclusively school-aged children, as many of them lost slots with school-aged children taking priority
- Child Care Facilities such as Roberta Webb Child Care Center and Harrisonburg/Rockingham Day Care Center

# **Establishing Need Categories**



#### Coronavirus Relief Fund Federal Guidance

The CARES Act provides that payments from the Fund may only be used to cover costs that—

- 1. are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID—19);
- 2. were not accounted for in the budget most recently approved as of March 27, 2020 for the State or government; and
- 3. were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.2



#### Eligibility Review

The Task Forces' identified community needs will be turned into defined categories at today's meeting.

After today City staff will begin closely reviewing the categories and identified needs through the lenses of the federal guidance.

The federal parameters may unfortunately lead to some community needs identified by the Task Force being deemed ineligible for this funding.



#### Eligibility Review

"Such a program should be structured in such a manner as will ensure that such assistance

is determined to be necessary

in response to the COVID-10 public health emergency and otherwise satisfies the requirements of the CARES Act and applicable law."
