

NOTICE OF PUBLIC HEARING & COMMENT PERIOD COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM (CDBG) CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT (CAPER)

The City of Harrisonburg is seeking public comments for the required CAPER - a document required by the U.S. Department of Housing & Urban Development (HUD) for the evaluation and review of CDBG programs in program year 2019.

Comments may be submitted during the CDBG CAPER Public Hearing portion of the regular City Council meeting on November 10, 2020, at 7:00 P.M. in the City Council Chambers, Harrisonburg Municipal Building, located at 409 S. Main St., Harrisonburg, VA. All comments must be received no later than November 27, 2020 at 9:00 A.M. Copies of the draft CAPER will be available for review in the City Manager's Office, 409 South Main Street, Harrisonburg, Virginia 22801 and at www.harrisonburgva.gov on the CDBG homepage. A summary of the CAPER is as follows:

In the 2019 year, the city was awarded \$576,573 in CDBG entitlement funds. \$693.39 of unexpended funds from previous CDBG years were also added to this number, bringing the total amount to \$577,266.39. The following is a summary report of obligated, expended, and remaining funds as of 6/30/2020:
