Dear Ms. Dang,

Susan and I are applying to close approximately 1,248 square feet of the undeveloped alley between Myers Ave and Monticello Ave, which is an extension of the Mountain View Dr right of way.

We are asking to close only that portion of it on the south side of the area the city wants to retain for a shared-use path, which is laid out in the maps provided by the city. This is a revision of our earlier request in July, which now asks to close a longer, but narrower strip of land adjoining our yard. After working with you and the city staff and with the Fergusons, who live on the north side of the right of way, I think we have reached a neat compromise that will satisfy everyone. We will get a nice place to have a leveled lawn with mountain views, our neighbors will have a clearly designated shared-use route between Myers and Monticello, and the Fergusons will be able to add land to their lot.

Once again, we thank you and the city staff for all of the time you have and are devoting to this request.
