Consider requests from Christopher and Susan Versen to close +/- 1,248 sq. ft. of undeveloped right-of-way and from Jeffery and Bonnie Ferguson to close +/- 1,288 sq. ft. of undeveloped right-of-way located between Myers Avenue and Monticello Avenue. The portions of undeveloped public right-of-way requesting to be closed are adjacent to tax map parcels 26-V-1, 27-T-1, and 26-S-15.

Any person requiring auxiliary aids, including signers, in connection with these public hearings shall notify the City Manager at least five (5) days prior to the time of the hearing.

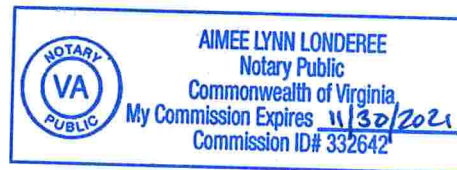
