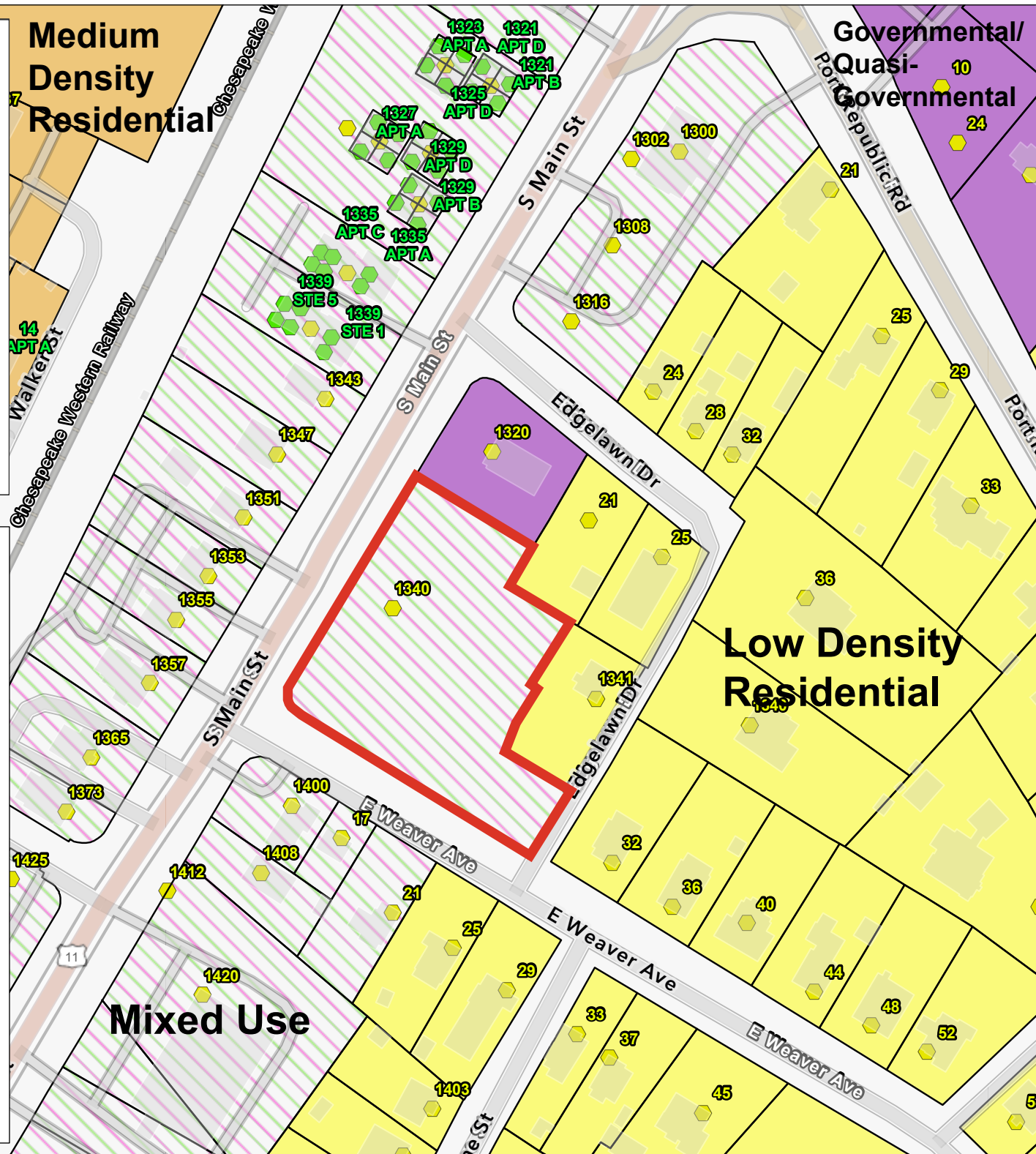
(Future) Land Use Guide
