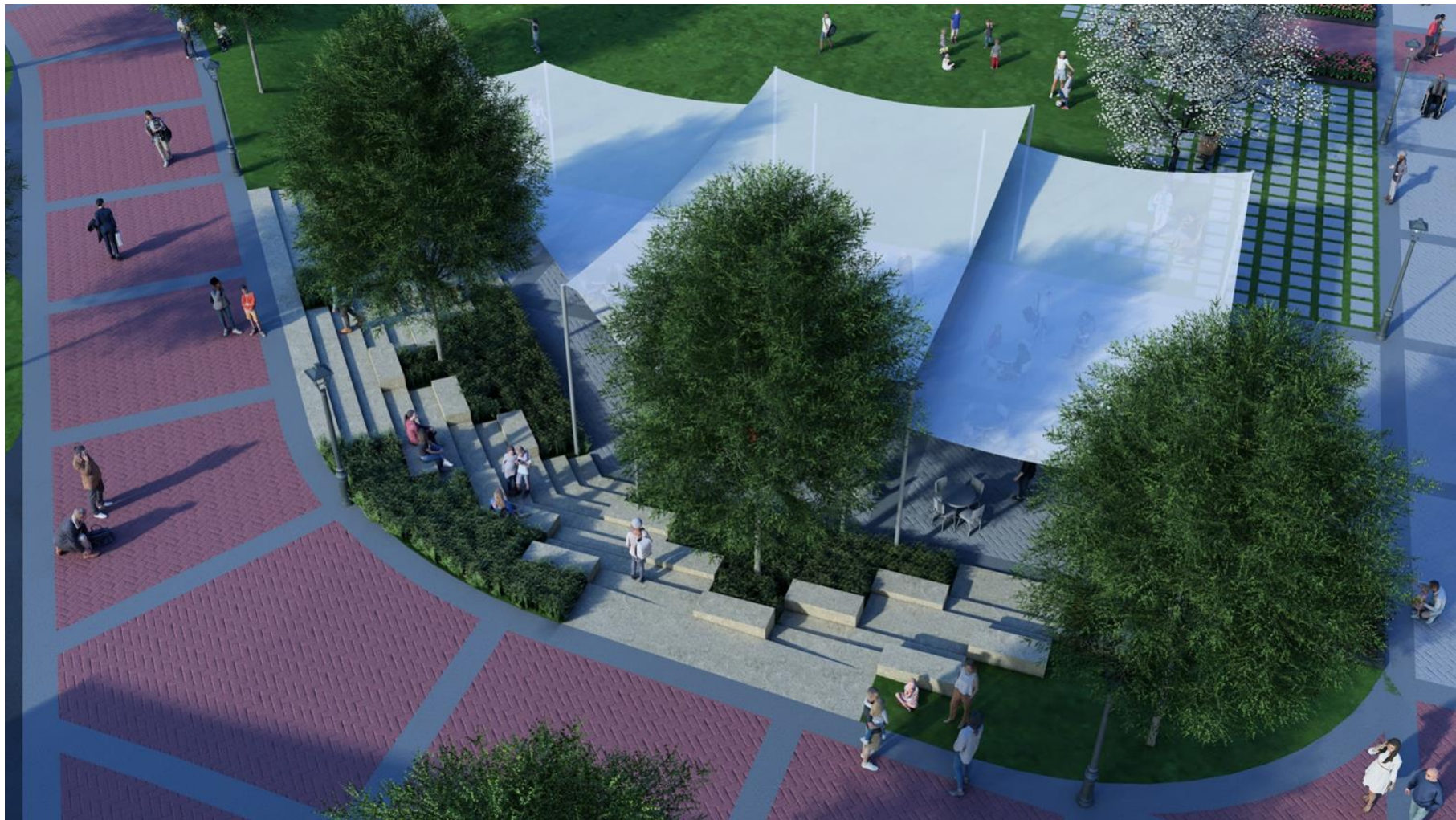










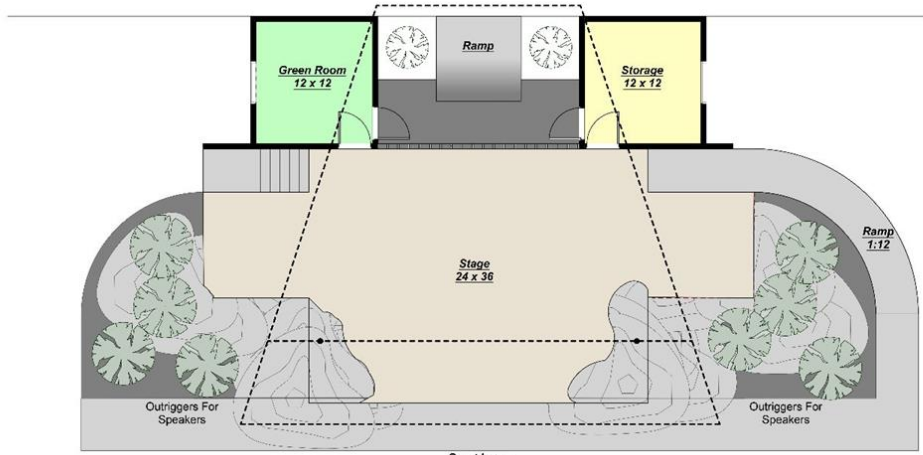




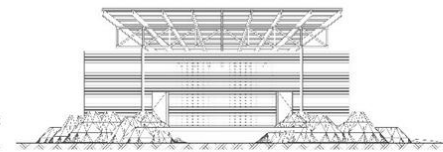




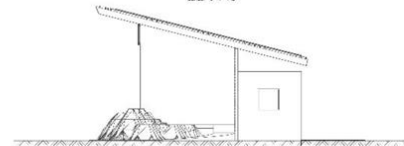




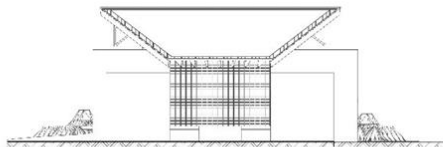
**Stage Plan**

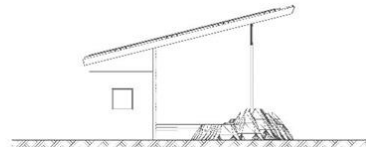
**North Elevation**

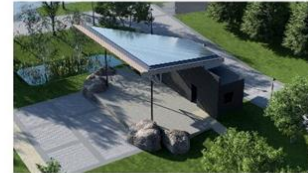
**West Elevation**
