Mr. Wong then shared information on the Great Community Give and expressed thanks to the Commissioners for their support.

Mr. Wong then provided updates on current projects. He related of working with Virginia Community Development Corporation for the underwriting of Bluestone Town Center. He stated of still outstanding issues with finalizing the Part 58 and Subsidy Laying Review. These items are needed for the agreement to enter into a housing assistance payment (AHAP) for the project basing of vouchers and use of the HOME funds. He stated that bids are due for the Lineweaver renovation project on April 22. He related the plan to present bid proposals to the board at the May meeting. He stated of the need to work with the owners of the Glen's Fair Price property for a purchase extension due to the delay in closing.

We communicated two important things to landlords this month. First, HRHA will not be approving rent increases for the rest of calendar year 2026, except in very limited cases where the request meets rent reasonableness and stays within our 2026 payment standards. That step is necessary to help us avoid a budget shortfall and protect assistance for the families we already have housed. Second, we reminded landlords to stay ahead of mold-related issues by addressing leaks, water damage, staining, peeling surfaces, visible mold-like substance, and other signs of excess moisture as early as possible, so we can reduce failed NSPIRE inspections and avoid more serious corrective action.

Program Highlights

During this reporting period, the Family Self-Sufficiency (FSS) Program implemented several activities to support participants' progress toward economic independence. FSS had a new enrollment this month.

FSS facilitated a financial capability workshop in partnership with Everence Financial. The workshop focused on strengthening participants' financial literacy and promoting the development of sustainable financial habits, including budgeting and financial planning.
